TRAUMATIC BRAIN INJURY (TBI) AND POST TRAUMATIC STRESS DISORDER (PTSD)

The American Legion has continued to be concerned with the unprecedented numbers of veterans returning from the Operation Enduring Freedom (OEF), Operation Iraqi Freedom (OIF) and Operation New Dawn (OND) with Traumatic Brain Injury (TBI) and Post Traumatic Stress Disorder (PTSD), which have been called the "signature wounds" of these conflicts

The American Legion convened a TBI and PTSD Committee in 2010 "to investigate existing science and procedures and alternative methods for treating TBI and PTSD.

During the three year study, the committee held six meetings and met with leading authorities in the DoD, VA and personally interviewed veterans.

#### The TBI and PTSD Committee found:

Most of the existing research for the last several years has only validated the current evidence-based treatments

Those treatments are defined by DoD/VA's Joint Clinical Practice Guidelines as – cognitive processing therapy, prolonged exposure therapy and antidepressants.

There seems to be no fast track mechanism within DoD/ VA for employing innovative or novel therapies in a standardized way.

While a number of VA Medical Centers offer some sort of Complementary and Alternative Medicine, it is not offered in any uniform or consistent manner within DoD or VA's 152 VA Medical Centers across the country.

#### The TBI and PTSD Committee recommended:

Congress provide oversight and funding to DoD/VA for innovative TBI and PTSD research currently being used in the private sector, such as hyperbaric oxygen therapy, virtu7al reality exposure therapy and other non-pharmacological treatments.

Congress increase the budgets for DoD/VA to improve the research, screening, diagnosis and treatment and direct DoD/VA to develop joint offices for collaboration between DoD/VA researches.

DoD/VA accelerate research efforts to properly diagnose and develop evidence-based treatments for TBI and PTSD.

The America Legion believe that all possibilities should be considered in the attempt to find treatments and cures for these conditions affecting significant numbers of veterans, including alternative medicine. And, if shown to be effective, these treatments and cures should be made available to all veterans. The American Legion has created a permanent TBI and PTSD committee to continue to build upon our knowledge and understanding of TBI and PTSD and to provide Congress, DOD and VA with the data and recommendations they need to effectively treat veterans.

The **"BRAVO ZULU"** award is the Department Commanders Version of the **"Billy Award"** and is awarded to a Legion Family member for Outstanding Service of Excellence!



In the United States Navy, it is a common practice for the Commodore or

Fleet Admiral to signal ships that have performed exceptionally well with the "BRAVO and ZULU" flags. These two flags displayed together mean "Well Done"!

## We're Going Back To School

A new year is upon us and it will be a wonderful year!

After going to Post 29 in Miami in May and seeing how well this event went for the Post, it made me excited to be able to assist your Post to do a "revitalization". Part of revitalization is membership, however, there is more to helping your Post grow and develop into a place where Veterans and their families want to go and do things.

Do you advise your members that their membership expires on December 31st. and help them to renew prior to that time? It is important to make sure that all of your members are aware of this. Do you have time set aside to make phone calls to each of your members who may not have paid at the time and date? Do you use Mylegion.org to see if there are members of the American Legion in your area who do not have a permanent Post? It is a good place to find members.

When your community has an event do you have a table with brochures, applications, and information regarding the American Legion available and someone willing to talk to the Veterans in your area?

Have you had a couple (man and woman) come into your lounge and only ask if the male is a Veteran and not ask the female? Please ask both! Then you may end up with two members rather than losing both because you did not ask both of them. Please do not forget that Women are Veterans too.

It is strongly recommended that when you sign a new member up and/or have a member transfer from Post 400 that you ask for proof of their service to our Country. In recent events within the American Legion there are circumstances where a DD 214 may have been altered. Also, when you have an individual who stops into your Post and decides to transfer to your Post, please request a copy of their documents. You do not have to maintain the copy, however, you really should see it and review all of its information.

Examples of the above are: a member of another Post moved from one city to yours, they decide they wish to transfer and when asked for their DD 214 it was discovered that the Veteran missed the eligibility dates by 17 days. He should immediately be advised that he/she does not qualify. However, this person was asked if he might have a father or grandfather who may have served and if he did, he was offered an opportunity to become a member of the Sons of the American Legion. This also goes for our female veterans, as well. A male and his wife comes into your Post and starts talking about his service. You discover that the individual is not old enough to have served in the Era that he claims to have been in, ask for that DD 214 or discharge information. If they do not qualify, they should be offered an opportunity to become members of the American Legion Auxiliary.

Should you have the desire to have assistance in revitalizing your Post, please contact Department or, should you have a question, please call me. If the phone isn't answered right away, please leave a message.

Let's make 2014-2015 the best year for the Department of Florida and your Post in membership.

On June 17th, President Obama signed into law HR1726 which gave the Congressional gold Medal to Veterans of the 65th Infantry Regiment (known as the Boringueneers) for their distinguished service during the Korean War. The National Chairman, Frank Madina, of that group presented Michael McDaniel and I with certificate awards for the work our Department did to help encourage all 29 members of Congress to co-sponsor this bill. Florida was the first state to have 100% backing of this bill.

They can give us or even take away what was given if we do not have the proper support in the field to contact them with our wishes.

#### Sen. Sanders Seeks New VA Funding Compromise

A push by Veterans Affairs Department officials for billions in new funding to hire more doctors may upend congressional efforts for a wide-reaching VA reform package that appeared all but finished just a few weeks ago.

On Wednesday, Senate Veterans' Affairs Committee Chairman Sen. Bernie Sanders, I-Vt., said he wants to include portions of VA's new \$17.6 billion funding request in a larger veterans omnibus bill that is already being finalized by a House-Senate conference committee.

That measure already comes with a \$35 billion price tag that senators have questioned and that House members have insisted must be paid for with budget offsets.

Sanders would not put a cost estimate on his idea for a new bill, but said he expected all of the items would cost far less than \$35 billion – a figure he noted both chambers have already initially approved.

"Nobody gets everything they want," he said, promising cuts to what VA has asked for. "But I think we can get that number down, and believe we can still put together a strong bill."

But House Veterans' Affairs Committee Chairman Rep. Jeff Miller, R-Fla., has already publicly balked at the new funding request, saying Congress has received few details on how the money will be spent.

"I am committed to giving VA the resources it needs to provide our veterans with the care and benefits they have earned," he said in a statement last week. "But if there's one thing we've learned over the last few months, it's that we can't trust VA's numbers."

In testimony before the Senate, Acting VA Secretary Sloan Gibson said the \$17.6 billion would be used to hire about 10,000 clinicians over the next three years and secure more space for medical appointments through leases, VA facility improvements and new construction.

He insisted the moves would help cut down on veterans' medical appointment wait times not just in the short-term but also for years

Gibson is scheduled to brief House lawmakers on the funding request Thursday morning.

Congress has only a few legislative days left before an extended summer break begins Aug. 2. Any work left undone would not be finalized until mid-September at the earliest, and more likely would sit until after the November mid-term elections.

That gives the veterans' legislation conference committee about a week to not only finalize the new funding plans but also find a compromise on offsets to pay for the measure – issues that have remained unresolved since June.

Sanders said not getting the work done before the August break would be "a disgrace."

"We should be able to come together on this," he said. "If there's a will, we can do it. If there's not, we will fail."

#### Selecting a Service Officer

Before selecting a service officer, you, the veteran, must have an idea what a service office is and isn't. First things first, a County Service Officer or a Post Service Officer is not a representative of the VA. Service Officers are a veterans' advocate and it doesn't matter between County Service Officers or Organizational Service Officers (DAV, VFW, American Legion, VVA etc.). At the end of the day every veterans service advocate desires to help each veteran receive all the individual benefits and opportunities earned by honorable military service to this country. In its most basic form, a veteran's advocate is someone who cares about veterans and supports their causes.

With respect to the claims process through the Department of Veterans Affairs, the veterans advocate takes a greater role and responsibility; it's the advocate's obligation to present the veteran and his or her claim in the most concise, accurate and complete manner to give the VA rating officer a complete package on which to base a decision.

The service officer must work directly with the veteran or family to identify all the possible benefits the claimant may be entitled. This often involves hours of interviewing and analysis of medical and military records to ascertain the status of the veteran's health or financial situation.

However the role of the Service Officer doesn't start with the veteran walking through the door. It begins long before, in our attempts to educate the public and veterans on services we offer and the benefits they have earned. Although the veteran may realize how military service ultimately affected their health, talking about wounds or injuries has never been something people hide. For example, when a veteran received compensation for Agent Orange exposure and resulting conditions caused by that exposure, every veteran he runs across is quickly informed of conditions that may be caused by exposure or service, and urged to follow the appropriate claim. In contrast, financial status or well-being is not often discussed outside the family. This coupled with an overwhelming pride not to take advantage of programs such as welfare brings about relative obscurity of the VA pension benefits.

Once a veteran or his family member comes to a Service Officer for assistance, it is the service officer's responsibility to determine eligibility for compensation, pension or other benefits through the VA. Like our entire counterparts throughput the nation, we must develop the case, review the pertinent information, and prepare a claim for the veteran to submit. We are often able to facilitate the compilation of additional information when it is necessary, thereby limiting the longer waiting times. In addition, we receive our complimentary copy of the notice of decision for our records, so we can be proactive in reviewing the decision and determining a course of action before the veteran has received the same letter.

#### Problems for Service Officers:

Claims jumping: Service Officers inherit many claims that he/she did not initially develop and did not submit to the VA. This is often more time consuming than the establishment and development of the case from the beginning. Jumping from Service Office to Service Officer usually gets you into more trouble, causes more delays and confusion because the Service officer does not have a clear picture of the case from the beginning.

#### Worthless Claims:


There are approximately 800,000 claims in the back log across the Unites States. Many of these claims are what we Service Officers call Worthless Claims. Worthless Claims are those that have NO MERIT, no evidence of a service connection and in most cases is wishful thinking on the part of the veteran. These claims are much of the problem, creating major back log issues.
