step toward providing transitioning service members with the information and skills they need to successfully transition into civilian life.

TAP coordinates the efforts of the Department of Defense (DOD), the Department of Veterans Affairs (VA), the Department of Labor (DOL), and the Small Business Administration (SBA), as well as VSO partners, to provide an overview of the benefits available to separating service members, as well as training in how to successfully acquire and maintain civilian employment. As such this program is an important asset to our veterans.

However, with the advent of the mandatory budget cuts known as "sequestration," defense spending has become severely limited. Because of this, DOD is force to reallocate funds toward readiness and training. This means that TAP is facing the potential of budget shortfalls, even as a drawing down of the military is pushing many service members from active duty.

Some estimate that as many as 250,000 service members will be transitioning annually from military service over the next several years. Many military personnel have little or no civilian experience, and little knowledge of how to acquire appropriate civilian employment.

TAP helps to fill some of these gaps, by connecting transitioning service members with resources to assist in finding employment, and by providing training on basic skills such as resume writing, and interviewing for jobs.

Cuts to TAP, coupled with the massive military drawdown, could prove disastrous for separating service members who need the information and training provided by TAP.

Going through proposed Post Constitution and By-Laws I have noticed that many Post are making the same mistake regarding how Post meetings are conduct-

ed. Most Posts Constitution and By-Laws say that all proceedings of this Post shall be in accordance with Robert's Rules Of Order.

The Department Constitution in Article X, Section 18 states, "Each Post shall use and follow The American Legion Post Officers Guide in conducting its meetings, initiation of new members and other ceremonies prescribed therein."

It is important to note that should there be a question on procedure, the steps to follow would be to refer to (1) Post Constitution and By-Laws, (2) Department Constitution and By-Laws, (3) National Constitution and By-Laws, and as a last resort refer to Robert's Rules Of Order.

Another thing I have noticed is that most Posts do not have any reference to those who have access to and handle funds of the Post being bonded. Any Post officer, member, or employee who has access to and handles money should be bonded.

This is a no brainer, it protects the Post in case someone gets "sticky fingers." Most insurance policies have coverage available for the bonding of those with access to Post funds. A Post should check with their Insurance Agent before they go to a Bonding Company to obtain bonding of those individuals.

One more problem that I have noticed lately is that some Posts believe that the Post Executive Committee can suspend, or sanction a member for various reasons, I would remind you that the Department Constitution in Article X, Section 14 specifically states: "Members or Post Officers may be reprimanded, suspended or expelled from the American Legion only upon proper showing or cause. Charges shall be based upon disloyalty, neglect of duty, dishonesty and conduct unbecoming a member of The American Legion. Charges must be made under oath and in writing by the accusers, and no member or officer shall lose his membership or office until given a fair trial."

POST EXCELLENCE AWARD



To qualify for the Post Excellence Award, a post is required to achieve excellence in four areas: membership, youth activities, community service and support to currently serving troops or veterans.

The purposes of this award are membership growth, exposure of American Legion values to the youth of the community, and increased visibility of the American Legion Family through service projects. A post achieving this qualification will have had numerous post members involved in planning and achieving these goals.

Many posts are most likely already active in these areas and will qualify without extra effort. Others, however, will need to increase their efforts in one or more areas to qualify for the award.

The standard to be achieved in each area:

- Membership. Must be at least one member greater than the previous year. At least one post officer attends district meetings.
- Youth activities. Must sponsor and actively participate in at least one primary youth program: Boys State, American Legion Baseball, Oratorical, Boy Scouts or Junior Shooting Sports.
- Community service. Must accomplish a community service project with members of the Legion Family actively working in the community outside the post home. A wide range of potential projects exists, such as a project centered on one of Children & Youth's emphasis areas to fulfilling a strictly local need. A monetary donation may be part of the project but may not constitute the entire project.
- **Service to troops/veterans.** Must accomplish a project supporting troops or veterans in the community with Legion Family members outside the post home. Potential projects include the Family Support Network, Heroes to Hometowns, or simply helping a local veteran with necessary updates to his or her home. Again, a monetary donation may be part of the project but may not constitute the entire project

The district commander responsible for the post will certify a post as having achieved the four specified criteria. The district commander will submit a list of posts meeting the criteria to the department headquarters. That list should include the post name, post number, post address and post commander's name. Ideally, the last two criteria are accompanied by copies of press releases submitted to the local media about the projects. That method ensures the projects were not only accomplished but that an attempt was made to enhance the image of The American Legion through local media. The copy submitted should include a date and time stamp showing receipt by the media outlet.

All Posts that Submit for this award will also receive a Department Commanders **"BRAVO-ZULU"** Streamer. The department adjutant will transmit information as posts qualify to:

It is now time for all posts to have your Year End Medals ordered from Emblem Sales for the ROTC/JROTC Year End Awards ceremony and Military Balls. They will be held starting next month for some schools. You MUST be proactive and contact the individual schools to get the dates for the presentations. Don't wait until they contact you. Remember only 4 year college/university programs get a gold medal. Two year programs get the silver medal and all High School Medals are bronze including the Charter and Academy Schools. There are 2 Medals. One for Academic Excellence and one for Scholastic Excellence. Let's make sure every program in the state of Florida is sponsored by a post. Legionnaires of Florida, I need your help. Department Commander Conti has asked me to chair a committee to identify and locate immigrants who are serving or have served in the United States Military and for one reason or another are not Naturalized Citizens. I believe it is our responsibility and of utmost importance to identify and locate these individuals and assist them in beginning the Naturalization process. To wait could result in adverse action for our fellow veterans since we do not know the full scope of the legislative action pending in the US Congress on the national immigration issue.

I ask every member of the Department of Florida American Legion to assist me in helping these immigrants and fellow veterans become Naturalized Citizens. I suggest Posts place a Public Service Announcement in the local newsprint that The American Legion, Department of Florida is offering information and limited assistance to an individual

who meets the requirements for naturalized citizenship under Sections 328 and 329 of the Immigration and Nationality Act. The Department is in contact with the Local Field Office of the US Citizenship and Immigration Services and a legal expert in Naturalization. For more information, my E-mail address is immigration@legionmail.org.

In future months, I plan to have a seminar in Orlando at Department Headquarters for those immigrants who meet military service requirements of Sections 328 and 329 of the INA. I hope to have a representative from the USCIS and an expert from legal services for immigration. Further information shall be forthcoming as the seminar devel-
