Our Flag, our Pledge of Allegiance, our Boy Scouts, our veterans' memorials, our religious history and heritage, our American values can be seen as being under attack. The

courts are awarding the American Civil Liberties Union (ACLU) millions of dollars in taxpayer-paid "attorney fee awards" which are reported to be \$2.9 annually authorized under the Civil Rights Act, 42 U.S. Code Section 1988 (b). Due to the nature of its legal work, the fact that they take cases pro bono, and the fact that the ACLU is usually involved in cases against governmental

bodies, which are generally protected from severe financial judgments. Towns, states, or federal agencies, however, may be required to change its laws or behave differently, but may not be required to pay monetary damages unless given an explicit statutory waiver. Nonetheless, the ACLU has been awarded significant financial judgments when challenging governmental bodies in specific regards to the separation of church and state.

The American Legion has been opposed to the Civil Rights Act since the early 2000's, and while there are restrictions on how legal fees can be collected, the ACLU still receives substantial monetary awards in the event of favorable legal judgments, and the recovery of legal fees by nonprofit advocacy organizations remains common practice across the political spectrum.

1. A Federal Court in Riverside, California allowed the ACLU to pursue a precedent-setting lawsuit to remove a solitary cross from the Mojave Desert Veterans Memorial. ACLU attorneys were awarded \$63,000 for this case.

2. The ACLU reaped some \$940.000 in a settlement from the City of San Diego when it surrendered in ACLU's litigation to kick the Boy Scouts out of Balboa Park. The Boys Scouts are appealing. The American Legion has filed a friend-of-the-court brief supporting the Scouts. This case has been ongoing for close to a decade.

3. The ACLU received some \$500,000 to drive the Ten Commandments out of the courthouse of Alabama's Judge Roy Moore, notwithstanding the fact that the same Ten Commandments are on the massive doors and the wall of the U.S. Supreme Court itself.

4. Portland Public Schools were ordered to pay the ACLU \$108,000 in a case brought for an atheist who objected to the Boys Scouts being allowed to recruit during non-class time. In addition, the school district spent \$232,000 defending this suit. At the time of this writing, Portland is considering a complete ban. This case has also been ongoing for near a decade

5. The Los Angeles County Board of Supervisors surrendered on a 3-2 vote to the ACLU's demands that it change the county seal because of a tiny cross in one small panel representing the mission period of its history. The ACLU, exposing its hypocrisy as well as fanaticism, did not demand removal of the central religious figure dominating the seal – "Pomona," the Greco-Roman goddess of poma, i.e. fruits. A citizens' initiative petition is ongoing to place the issue on the ballot and overturn the surrender to the ACLU, for the 4th time. The new seal depicts a Native American

woman from the Los Angeles basin tribes.
6. The City council of Redlands, California reluctantly surrendered to the ACLU's demand that they change their city logo to remove a cross, for fear of court-ordered attorney fees to the ACLU.

Various judgments awarded to the ACLU and its state chapters have resulted from the undertaking of a wide variety of cases involving, creationism, internet pornography, the separation of church and state, and free speech. Total annual awards have been estimated to reach approximately \$2.9 million. Despite its monetary rewards by taking on highly contentious cases, the ACLU leaves itself significantly vulnerable to potentially damaging judgments if the organization was found to be filing a lawsuit deemed frivolous.

In feudal England, a Sgt.-at-Arms was an armed officer of a lord and was often one of a special body required to be in immediate attendance on the king's person, to arrest traitors and other offenders. Through this function, the title of Sgt.at-Arms eventually came to denote certain court, parliamentary, and city officials with ceremonial functions. (It has been suggested that we place a little humor in our articles so let me say that as Department Sgt.-at-Arms this year, I am not assigned to a "lord," or a "king" as they were in feudal England; I am honored to serve a "little leprechaun.")

I have had several calls from Posts asking how to being someone up on charges.

Article X, Section 14 of the Department Constitution explains step by step how to charge someone, and how to conduct a trial. You need to also check the Rules Governing Trials in the Amended Charter of the American Legion Department of Florida. This is found in the back of the Department By-Laws.

Follow the information in those two places and you will be OK. Remember, you must follow the steps outlined explicitly.

At the 98th National Convention the Subcommittee on Children and Youth met to reiterate established American Legion policies concerning children.

There were twelve resolutions considered and found merit to pass on to Congress. Two resolutions dealt with financial assistance to families faced with catastrophic illness and funding for comprehensive health care for children and youth programs. Three resolutions called for funding drug trafficking prevention programs, prevention of child exploitation and opposition to attempts to soften laws concerning distribution of pornographic and obscene materials to minors. Five resolutions addressed missing children, child maltreatment, child safety, teen pregnancy and juvenile justice. There was one call to establish a National Family Week and one to establish a National School Lunch Program. All resolutions passed with no amendments and submitted by the commission chair.

Legacy fund donations have exceeded the one million mark with a final total to follow. Several

states donations topped the \$100,000 mark with Florida donating \$79,000 collected during the In-State Legacy Run and donations made at Fall Conference and Summer Convention. inconvenience the postponement of the October class may have caused those who applied.

As a result of meetings held in Orlando in September and October, the FALC class has been re-scheduled for February 16-18, 2017. As a result of these meetings there is new focus on the future, ensuring the Department has an effective annual FALC. Coming out of the discussions is the belief that the FALC must be an effective leadership training program, done consistently on a year-to-year basis, be based on American Legion principles, "for the good of the Legion." Another outcome of the discussions is a proposal that the FALC may be more stable, more effective, and consistently done if it is planned and monitored by an "FALC Committee." The concept of such a committee, which is suggested to be comprised of five members, is currently being researched by the Department Adjutant for presentation to the Department Executive Committee. The suggested committee would consist of the Department Adjutant, the Department Commander and 2nd Vice Commander who would rotate yearly, and two other members appointed for multi-year terms.

By now every Post should have received a letter and the agenda for the February 2017 class, and it has also been posted on the Department web site. The class content is based on recommended subjects published in The American Legion "Administrator's Guide for Department College." I ask Commanders at all levels to ensure the information gets out to membership. As I am writing this article, just days after Matthew's passing through, I realize that a full damage assessment still needs to be made not only here in Florida but also in some states to our north. I am thankful at this point that lives were spared, as this storm could have been much worse.

I want to bring some attention to the fact that Facebook played a significant role during the storm. I am speaking about how, here in the 5th District, many members turned to this social media outlet to keep us all informed of the physical status of our members as well as our Posts.

In the 5th District, Matthew came at an inopportune time for us. Many Posts in our District regularly serve meals, offer BINGO and other entertainment from mid week into the weekends. Also, the 5th District annual picnic was scheduled for October 8th and the monthly District Meeting was scheduled for October 9th, which were both cancelled. The safety and well being of our members and guests was of primary concern in that decision to cancel the events.

Social media, namely Facebook, largely contributed to the communication role in the notification process to our members. Post commanders decided early on, to close those Posts that were in the projected path of the storm, and the messages were immediately posted to Facebook, alerting not only our members of our status, but also the community, thereby keeping people from needless travel to our already closed Posts.

Individual members also posted their status, which in turn advised everyone of areas that were without power, water, trees down, etc. Although there were many areas in the 5th District for which mandatory evacuation had been ordered, many opted to hunker down and ride it out. Facebook provided us with a notification system that allowed each and every user to mark their own personal status of being safe after the storm.

Many areas in the 5th District experienced the loss of power and in some areas for more than 48 hours. Mobile communications were kept active through generator backup at the cell towers, allowing for social media interaction throughout the storm.

Chapter 6

How Does VA Coordinate Care for Veterans Who Are Traveling or Living at Temporary Address? (VA Entitlements Chair - Continued)

Generally, the VA Primary Care Team is responsible for care for Veterans traveling or temporarily experiencing a change of address – such as living on one state during the winter and another during summer. Any VA provider seen while traveling will share information and coordinate treatment options with the Primary Care Team.

Coordination of Care with Providers Outside the VA Network

(Co - managed/Dual Care)

We strongly encourage enrolled Veterans to receive all their health care through VA. However, if private doctors continue to provide treatment, VA will work with them to meet health care needs and coordinate effective treatment, we call this Co-Managed Care or Dual Care, which means that the VA and private doctors will work together to provide safe, appropriate, and ethical medical care.

VA's Primary Care Team is responsible for managing all aspects of care and services available through the VA system. Under no circumstances can the VA provider simply re-write prescriptions, or order diagnostic tests from an outside provider, without first making a professional assessment that a particular test or drug prescription is medically appropriate. If the VA provider does not follow the recommendations of a private provider, she or he will communicate the reasons for such decisions and may offer alternative treatment recommendations.

Coordination of Care Among VA Facilities

Veterans may receive medical attention in variety of VA settings – clinic, hospital, emergency rooms, Community Living Center (formerly known as VA nursing home), or their own residence. Care will be provided by professionals who offer diverse specialized treatments and services. In order to

manage the different aspects of care effectively, the Primary Care Team will use VA's electronic medical record system to ensure the coordination of care.

Specialized Outpatient Care Not Offered at the Local Health Care Facility

If required care is not offered at the local health care facility, the Primary Care Team can arrange care at the VA health care facilities or in the community, as appropriate. Generally, the Primary Care Provider will coordinate the care at both locations.

Disagreements Between VA Providers and Private Providers

VA will work to ensure that health care needs and preference are met. And that there is an understanding of all available. VA providers have the final say about how VA will meet your health care needs. Including whether or not to order tests or write prescriptions.

Wherever you go, VA is there for you.

- Are you planning to travel, either within the U.S. or abroad?
- Are you interested in receiving treatment from private doctors, as well as your VA Primary Care team?
- Do you have questions about your health care benefits?


I have been receiving numerous emails and phone calls from Posts throughout Florida about the future of this program. I assure you that this program will
