The American Legion opposes policy of prohibiting the placement of American Flags on individual Veterans graves in National Cemeteries

The American Legion has an ongoing position to oppose attempts that would prohibit the placement of flags on individual graves. This was made clear in 1978 at the National Convention in New Orleans when delegates passed Resolution 498 titled "Oppose Any Plan to Stop the Decoration of Individual Graves in any National Cemetery" and by Resolution 214, National Convention 1997 at the National Convention in Orlando entitled "Oppose Policy of Prohibiting the Placement of American Flags on individual Graves in National Cemeteries."

President Abraham Lincoln, in 1862, signed legislation creating the national cemeteries and through the years it has been traditional and

customary to decorate the individual graves with the U.S. Flag. The flag represents the country for which they served and by displaying the National Symbol, the Country expresses a degree of appreciation to that veteran; that it remembers his or her service

The America Legion believes it is wrong that some national cemeteries have adopted policies prohibiting the placement of the flags while, at the same time, allowing floral and other items to be placed on the gravesites.

National Cemeteries are symbolically "American Cathedrals" where the living respect the memories and service of the veterans and family members interred therein. There is no more fitting remembrance of veterans and their service to this country than the U. S. Flag.

Legislation

Military Pay Increases 1.6 Percent for 2017

President Obama approved plans to cap the military's 2017 pay raise at 1.6 percent. In a brief letter to Congress last week, he said the cap was needed to maintain a "sustainable fiscal course."

House Republicans are hoping to override the President's rate with this year's defense policy and spending bills, but that effort is uncertain at best. The House versions of those bills provide troops a 2.1 percent pay raise, using a portion of the Overseas Contingency Operations fund to pay for the higher raise. But the Senate versions of those bills support President Obama's 1.6 percent raise.

Update on Flag Amendment Bill

On January 7, 2015, **House Joint Resolution (H.J. Res.) 9** was introduced by Rep. Steve Womack (AR). This legislation is a proposed constitutional amendment to protect the American

flag from physical desecration. Its text states simply: "The Congress shall have power to prohibit the physical desecration of the flag of the United States." In addition to Rep. Womack and the five original co-sponsors of the House joint resolution there are now a total of 42 cosponsors, with the addition of Reps. Lamar Smith (TX) and Leonard Lance (NJ) on September 6.

On July 30, 2015, Sen. David Vitter (LA) introduced Senate Joint Resolution (S.J. Res.) 21. The Senate measure has **9** cosponsors.

Additional cosponsors continue to be sought for both measures. [A listing of all cosponsors for both flag amendment bills is attached to the end of this report.]

Please contact or Senator and House Representative and see if they wish to be a cosponsor. All it takes is one phone call. Let me know if you do call and what they say. Thank you for the time and effort is this matter.

"You will guard especially against the loss of one of The American Legion's greater possessions, our deep and abiding spirit of comradeship."

Unfortunately, due to illness I could not attend the National Convention in Cincinnati, so I can't share any experiences with you about the parade and other activities. I thank all for the get well wishes, the e-mails and phone calls. The new chapter (#14) in the Sgt.-at-Arms Procedural Manual is now posted on the Department of Florida web site along with four Color Guard instructional videos. You can find these items under "Officer Reports." I hope that this new chapter and the videos will assist Posts and Districts that have color guard questions.

In the August 2016 Legion Link, we talked about the membership composition of the two basic Color Guard Units we typically use in The American Legion, the Military Class and Military Class –Open. This month let's review some of the equipment requirements for Color Guard Units.

The style and color of uniform will be optional with each unit, provided they are within the dignity and propriety required when carrying the National Colors. Headgear is required to be worn by all members of the unit. If the Color Guard does not wear Color Guard headgear specific to the Color Guard such as helmets or berets, members shall wear the official uniform hat of the member's organization within The American Legion Family. Required authorized equipment will consist of National Colors*, American Legion Organizational Banner, and at least two weapons. *DEFINITION - The Institute of Heraldry, Washington, D.C., has specified in Title 4 of the U.S. Flag Code, the 50-Star American Flag is the Flag of our Country (U.S. Colors); therefore, all others shall be treated as banners. Minimum size of U.S. Colors is 3 feet by 5 feet. No flag shall be larger in size than the U.S. Colors.

Additional authorized equipment, such as flags, sidearm, sabers and swords may be carried and can be simulated. "Replica rifles" may be used, as long as they have the same weight as the real rifle, plus the bolt mechanism. "Simulated rifles" (rifles of lesser weight with or without simulated bolt mechanism) should not be used. Rifles are defined as weapons that are hand operated and designed to be fired primarily from the shoulder. The surface of the rifle must

have bore and grooves to impart rotary motion to the projectile, which conform to the original design of military rifles, past or present. Sights, slings, barrels, trigger and trigger housing are optional. Bolts or simulated bolts are required. Side arms are defined as weapons, which are hand held and fired by means of a primer, percussion cap, or cartridge enclosed igniter. Sabers (swords) are defined as weapons which are designed to be hand held for cutting, thrusting or slashing an enemy, with either a curved (saber) blade or straight (sword) blade which may be constructed of any material and must have hand quard.

CORRECTIONAL INSTITUTION POSTS:

Exceptions to the weapons rules can be made as necessary for security reasons at American Legion Posts located in correctional institutions. The use of any real, replica or simulated sabers, sidearm, swords, or rifles is left to the discretion and approval of the Chief of Security, the Superintendent, or the Warden of the correctional facility.

Judge Advocate

There seems to be a misunderstanding regarding the term, "A Post shall be the judge of its own membership."

If an eligible veteran applies for membership in a particular Post, the membership of that Post votes on whether or not to accept the application for membership. The right of each Post to determine its own membership is without restriction.

In a 1937 ruling, the then National Judge Advocate stated: Regarding Article IV, section 1 of the National By-Laws, "In other words, a member may be eligible to join The American Legion, but this does not mean that he must be accepted for membership in a particular post. Eligibility is not synonymous with acceptability. If a member is eligible to join The American Legion, it is still the prerogative of the post to determine whether they will accept such member in their post."

The Post has the prerogative to accept, or not, whomever is eligible, provided that the Post does not refuse membership to an eligible veteran based on criterion prohibited by law, such as ethnicity, gender, age. etc.

Once an eligible veteran is accepted into a Post, the only way that person can lose his/her membership is by trial in accordance with Article X, section 14 of the Department Constitution.

Should a member request to transfer his/her membership to another Post, it is the prerogative of the Post the member wishes to transfer their membership to, to decide whether or not to accept the transfer. Should that Post decide not to accept the transfer, the member requesting transfer still maintains his/her membership in The American Legion.

We are honored to have The American Legion national Judge Advocate, Phil Onderdonk with us at the upcoming Fall Conference.

I would ask that all Post, District, and Area Judge Advocates please plan to attend the session from 3:00 to 5:00 P.M. on Friday November 18th, and try to be in attendance.

Mr. Onderdonk has been the National Judge Advocate for a number of years now, and is very up to date on the National Constitution and By-Laws. Again, please plan to attend this session. It would be nice to have a good turnout of Legionnaires in attendance.

Veterans are always asking me, do I qualify for VA Benefits All Information is from the VA Health Care Benefits Overview 2015 Edition, Vol.1 Basic

Eligibility for VA Health Care.

If you served in active military, naval or air service and are separated under any condition other than dishonorable, you may qualify for VA health care benefits. Current and former members of the Reserves or National Guard who were called to active duty (other than for training only) by federal order and completed the full period for which they were called or ordered to active duty may be eligible for VA health care as well.

Minimum Duty Requirements

(VA Entitlements Chair Continued)

Most Veterans who enlisted after September 7, 1980, or entered active duty after 16, 1981, must have served 24 continuous months or the full period for which they were called to active duty to be eligible. This minimum duty requirement may not apply to Veterans who were discharged for a disability incurred or aggravated in the line of duty, discharged for a hardship. Or received an "early out." Since there are a number of other exceptions to the minimum duty requirements, VA encourages all Veterans to apply to determine their enrollment eligibility.



Portraits of Tuskegee Airmen: Leo Gray

By Redtail.org ~ The CAF Red Tail Squadron has many special relationships with original Tuskegee Airmen, and we absolutely treasure them. These American heroes are unique, continuing to inspire us as much today as when they fought fascism abroad and racism back home in the era of WWII. We are honored to stand beside these great role models at many of our outreach events around the country. Leo Gray, an original Tuskegee Airmen and pilot, continues to share his experience with our audiences, inspiring the next generation to RISE ABOVE.



Gray, born in Boston, volunteered for service in 1943. He went to flight school at Tuskegee Army Airfield where he qualified for single-engine fighters. He was then assigned to Ramitelli, Italy where he flew 15 combat missions in the P-51 Mustang, logging 750 flight hours. He served 3 years and seven months active duty, and remained in the United States Air Force Reserves until 1984. He retired after 41 years of service with the rank of Lieutenant Colonel

"The Tuskegee Airmen are a classic example of overcoming adversity, and

people in our country should know about it," said Gray. "It is worthwhile for everyone."

During his military career, Gray was awarded the Air Medal with one Oak Leaf Cluster, a Presidential Unit Citation and the Mediterranean Theatre of Operation Ribbon with three Battle Stars. The Tuskegee Airmen collectively were awarded the Congressional Gold Medal by Congress in 2007 to recognize their "unique military record that inspired revolutionary reform in the Armed Forces."

After the war, Gray earned a Bachelor of Science at the University of Massachusetts and a Masters degree at the University of Nebraska, both in agricultural economics. For 30 years, Gray coordinated research for the USDA. He credits his military service as the catalyst that helped his civilian career by giving him the skill and perseverance to be successful.

Gray has played a leading role in the Tuskegee Airmen, Inc. organization, serving as president of the Miami and East Coast chapters. He also helped to form a new chapter in Walterboro, South Carolina, the location of advanced combat training for Tuskegee-trained pilots before being shipped overseas to combat from 1943 to 1945.

He is also a dedicated member of the Boys & Girls Club of America – of which he was a member himself in his youth – and is a co-founder of the organization's lonosphere Club in Broward County, Florida. This unique group gives members the opportunity to learn about all aspects of flying, including science and mechanics.

"There are many young people, especially in urban areas, who have not

been exposed to aviation," remarks Gray. "They need to understand what's available for them. Aviation is a field with many openings. Pilots and support personnel are in demand because of many retirements. People need to understand the impact that aviation has on different areas of the country."



Gray has been gracious enough to help make our outreach visits even more impactful and inspiring by appearing at several of our events. For example, earlier this year, Gray joined us in Florida to speak directly to school groups about the history and legacy of the Tuskegee Airmen, and how students can utilize the Squadron's Six Principles in their own lives —

Aim High, Believe In Yourself, Use Your Brain, Be Ready To Go, Never Quit, Expect to Win.

"The CAF Red Tail Squadron is one of the few organizations that has a hands-on approach to opening peoples' eyes to aviation and the history of the Tuskegee Airmen," he says. "The RISE ABOVE Traveling Exhibit gives young people the opportunity to find out things that might never have been exposed to."

Thanks to the ongoing hard work and perseverance of Tuskegee Airmen, including Lt Col (Ret) Gray, younger generations are learning not only about an important piece of American history, but about what grit, determination and strength of character really means.

The CAF Red Tail Squadron is a volunteer-driven organization dedicated to educating audiences across the country about the history and legacy of the Tuskegee Airmen, America's first black military pilots and their support personnel. Learn more at www.redtail.org.
