THE STAR-SPANGLED BANNER

The Star-Spangled Banner became our National Anthem on March 3, 1931, when President Herbert Hoover signed Public Law 823.

The American Legion believes that many millions of Americans cherish and respect the currently accepted version, both words and music, of THE STAR-SPANGLED BANNER, our National Anthem. This traditional version was first used in 1918 as the "Service Version" by the War Department for use in Army and Navy song books.

Many Americans have been offended by the disrespectful and unconventional playing, and singing of the National Anthem at sporting events. The American Legion encourages the playing of the National Anthem in its original and traditional rendition.

Some celebrities and public figures have voiced their opinions that THE STAR-SPANGLED BANNER should be replaced with AMERICA, THE BEAUTIFUL, GOD BLESS AMERICA or another song. The American Legion opposes any changes in the words and music of the National Anthem

as adopted under Public Law 823 of the 71st Congress.

- Fully fund a superior national Defense as the global war on terror continue.
- Limit outsourcing, Unify, VA's programs
- Institute gender-specific health, care for women veterans.
- Develop alternative treatments, therapies for PTSD & TBI
- Reclassify cannabis for medical research
- Support those who care for wounded veterans
- Provide mandatory end of service exams for reservists

We recently "saluted" in a new year, a new President, and some use the term 'salute' as a toast; generally it is a term of good will, a welcome, and a sign of respect.

As veterans, we know that a salute is a privileged gesture which shows a sign of trust and respect among members of the military. As a veteran's organization, we in The American Legion continue the practice of saluting when we address the Colors and when we make an official report to our Commander during assembly.

Although uncertain of its origin, historians believe the salute began in late Roman times when assassinations were common; or used when a citizen who wanted to see a public official had to approach with his right hand raised to show that he did not hold a weapon; or when knights in armor raised visors with the right hand when meeting a comrade.

Most historians believe, however, that the U.S. Military salute was influenced by the British Navy. The Naval salute differs from the "Open Hand" British Army Salute in that the palm of the hand faces down towards the shoulder. It was considered most undignified to present a dirty palm in the salute obtained by working all those ropes, oil, and other things on the ships, so the hand was turned downward 90 degrees.

In saluting, turn your head and eyes toward the person or flag you are saluting. Bring your hand up to the correct position in one, smart motion without any preparatory movement. The proper way to salute when wearing a beret or without headgear is to raise your right hand until the tip of your forefinger touches the outer edge of your right eyebrow (just above and to the right of your right eye). When wearing headgear, the forefinger touches the headgear slightly above and to the right of your right eye. Your fingers are together, straight, and your thumb snug along the hand in line with the fingers. Your hand, wrist, and forearm are straight, forming a straight line from your elbow to your fingertips. Your upper arm (elbow to shoulder) is horizontal to the ground. When

dropping the salute, bring your hand directly down to its natural position at your side, without slapping your leg or moving your hand out to the side.

With the recent inauguration of a new Commander-In-Chief fresh on our minds, some may wonder how the President, a civilian, can return a military salute. Many believe the practice began in modern times with President Ronald Reagan. About the tradition, Ronald Reagan said:

"As Commander In Chief, I discovered it was customary for our uniformed men and women to salute whenever they saw me. When I'd walk down the steps of a helicopter, for example, there was always a Marine waiting there to salute me. I was told presidents weren't supposed to return salutes, so I didn't, but this made me feel a little uncomfortable. Normally, a person offering a salute waits until it is returned, then brings down his hand. Sometimes, I realized, the soldier, sailor, Marine, or airman giving me a salute wasn't sure when he was supposed to lower his hand. Initially, I nodded and smiled and said hello and thought maybe that would bring down the hand, but usually it didn't. Finally, one night I told the Commandant of Marines, "I know it's customary for the President to receive these salutes and I think there ought to be a regulation that the president could return a salute inasmuch as he is commander in chief. 'Well, if you did return a salute,' the general said, 'I don't think anyone would say anything to you about it.' The next time I got a salute, I saluted back. A big grin came over the Marine's face and down came his hand. From then on, I always returned salutes."



In the next Legion Link I will offer a few tips on preparation for the upcoming District Constitutional Conferences. Having attended so many over the past few years I've seen things done various ways and would like to offer some tips based on my observations. After all, one of the responsibilities of a Sgt.-at-Arms is to set up the conference hall and to identify all the guests for introduction and escort to the podium, in order to help the District Commander have an organized and successful DCC.

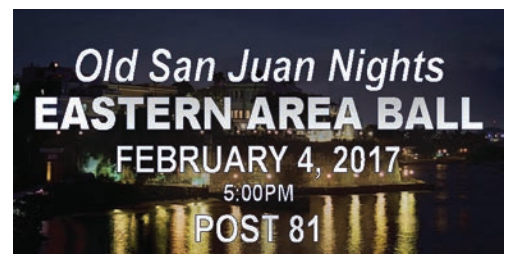

Potential Exposure at Fort McClellan

Fort McClellan was an Army installation in Alabama that opened in 1917.

Some members of the U.S. Army Chemical Corp School, Army Combat Development Command Chemical/Biological/Radiological Agency, Army Military Police School and Women's Army Corps,

among others, may have been exposed to one *(VA Entitlements Chair- Continued)* or more of several hazardous materials, likely at low levels, during their service at Fort McClellan. Potential exposures could have included, but are not limited to, the following:

- **Radioactive compounds** (cesium-137 and cobalt-60) used in decontamination training activities in isolated locations on base.
 - **Chemical warfare agents** (mustard gas and nerve agents) used in decontamination testing activities in isolated locations on base.
- Airborne polychlorinated biphenyls (PCBs)** from the Monsanto plant in the neighboring town.

Although exposures to high levels of these compounds have been shown to cause a variety of adverse health effects in humans and laboratory animals, there is no evidence of exposures of this magnitude having occurred at Fort McClellan.

PCBs and the Monsanto chemical plant

From 1929 to 1971, an off-post Monsanto chemical plant operated south of Fort McClellan in Anniston. PCBs from the plant entered into the environment, and the surrounding community was exposed.

In 2013, the Agency for Toxic Substances and Disease Registry (ATSDR) completed an assessment of the potential health risks caused by airborne PCBs in Anniston and concluded that the concentrations found were "not expected to result in an increased cancer risk or other harmful health effects in people living in the neighborhoods outside the perimeter of the former PCB manufacturing facility."

Fort McClellan today

Fort McClellan closed in 1999 as part of the Army Base Closure and Realignment Committee (BRAC) program. The BRAC legislation required the environmental cleanup of Fort McClellan prior to its transfer to the public domain. Oversight of parts of the base have since been transferred to the Alabama Army National Guard, Department of Health and Human Services, Department of Justice, and the Department of the Interior, as well as to the community of Anniston, where the re-development and re-use of the land is overseen by the McClellan Development Authority.

Veteran health care and compensation benefits

Veterans who are experiencing health issues that they associate with their service while at Fort McClellan should see their primary care provider or contact their local Environmental Health Coordinator.

Veterans may also file a claim for disability compensation. VA decides these claims on a case-by-case basis.

Our goal is to provide you with a publication you can be proud of, and we're happy to put in the time on your behalf, so we hope you will too!

THE PROCESS

Phase I: Collection

- Deadline** The deadline for articles is the 15th of each month. Articles received after this date will be saved until the following edition.
- **Reminders** We'll send out multiple group mailings to remind you your articles are due, up until the deadline. If you have turned in your article, and receive a reminder, please don't worry. Emails are sent to group emails, they go to everyone on the list, whether you have submitted an article or not.
 - **Content** Officer Reports, big news, upcoming events, veterans' issues...we want to hear it all. We do reserve the right to edit and/or deny certain content that does not align with the purpose and ideals of our organization.

 - **File Format** Send in a digital format (email, Word Document, etc) with regular font size and basic formatting. No need to do anything fancy, we'll make it look nice.
 - **Photos** Any photos should be sent as separate attachments and not embedded within documents. Otherwise the quality isn't nice.
 - **Confirmation** When Allyson receives your article she will send you a quick confirmation, and then you can ignore our future reminders.

Phase 2: Publication

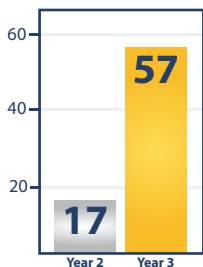

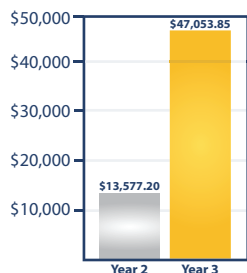
NUMBER OF FAMILIES ASSISTED

first 6 months of fiscal year (Jan - Dec)

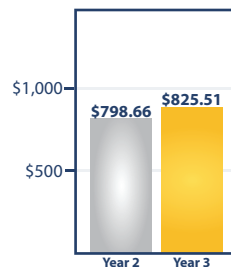
Number of Support Cases
