VA Recruitment and Retention

A 2017 Government Accountability Office (GAO) report revealed significant challenges in recruiting and retaining clinical and human resources employees at VA. Exit surveys indicated that advancement issues or dissatisfaction with certain aspects of the work environment were common reasons for departure.

In September 2017 there were 49,000 unfilled positions at VA. The Veterans Health Administration alone had 45,000 clinical vacancies, and 1,500 were mental health openings. VA currently has more than 20

health-care systems without permanent directors nationwide; some have gone more than two years under interim leadership. The GAO determined that the largest critical needs were medical officers, nurses, psychologists, physicians' assistants and medical technologists.

VA also needs to do a better job showing why it is a good place to work and offer meaningful incentive to recruit and retain top talent.

The American Legion understands that filling high-skill medical vacancies at VA facilities around the country is challenging. Creative solutions can be achieved, many without additional legislative action, to continue

providing, through full staffing of top professionals, what has been defined as "the best care anywhere."

The acute shortage of doctors, nurses, and other health-care professionals across the U.S., is particularly acute in rural areas and low-income inner-city neighborhoods.

WHAT CAN CONGRESS DO?

Congress can pass legislation addressing the recruitment and retention challenges VA has regarding pay disparities among physicians and medical specialists who are providing direct health care to veterans according to the many testimonies The American Legion has provided to Congress.

I get a lot of calls from Legionnaires with questions regarding something that happened in their Post, wondering what to do. My first reply is, "what does your Post Constitution and By-Laws say about it." The reply they mostly give is, "I don't Know."

You will find that most of your concerns will be answered in the Post Constitution and By-Laws. If not, look in the Department Constitution and By-Laws.

I received a call yesterday from a Post Commander asking why Post Officers are installed by the District Commander. Seems this Post Commander has a personal dislike for the current District Commander.

I reminded this Post Commander of the Department Constitution, Article X Post Organization, paragraph 13 which says: Post Officers shall be installed by the District Commander or his/her designated representative. Post Officers shall take office and enter upon their duties at a date to be fixed by the Post, which date shall be subsequent to, but not later than sixty (60) days after the adjournment of the Annual Department Convention, unless waived in writing by the incoming District Commander.

The only recourse for this Post Commander would be to write the current Department Commander requesting a former District Officer to perform the installation.

The American legion Department of Florida has contracted with Publishing Concepts (PCI), a trusted partner, to create this special member publication.

Watch for postcards and emails from PCI with instructions to update your information so we can take advantage of this great opportunity to celebrate our rich history and heritage!

<u>The American Legion, Department of Florida</u> has contracted <u>Publishing Concepts</u> (PCI), a trusted partner, to create a special **Florida 100**th**Anniversary Member Directory Publication**. This project was approved by Florida Membership at our 2017 Department Convention and has been approved by the National Headquarters office.

As member privacy is a concern to everyone, it is important to note that member's information will **ONLY be used or printed with their consent**. PCI has entered into a List Protection Agreement with National and as such PCI will only provide your information back to Department Headquarters. The publisher works under a very strict confidentiality agreement and will only use the information provided for the purpose of contacting members to gather data and to sell the directory.

There are 3 parts to the "Member Verification" process:

- 1. **Update and verify your information** for our records. During this portion, PCI will ask additional questions such as alternate addresses (for snow birds), date of birth, spouse name, etc. This will assist Department in maintaining accuracy in our records.
- 2. **Opportunity to OPT-IN to the Florida 100th Anniversary Member Directory Publication.** Here PCI will ask the member if they would like to have any or all of the following information printed in our directory: NAME, CITY, STATE, EMAIL, MILITARY STATUS, RANK, BRANCH OF SERVICE, LEGION POST, and WAR ERA. Members must OPT IN and may choose which information is printed in the directory.
- 3. **Ability to Purchase Directory and Florida Legion Merchandise.** PCI will attempt to sell the member a copy of the book and Department branded merchandise. Purchase is not necessary to be listed.

Every current member will receive a post card over the next few months. PCI will also be reaching out to expired members for the same information and will try to renew their membership, as a part of this call since they must be a member in order to purchase or be a part of the membership directory.

I am extremely honored to have been asked by Commander Boland to serve as your Department of Florida Membership Chairman. Moving into the 100th Year of The American Legion membership is the most critical focus we must have. If we do not get growth within the Family our ability to serve our Veterans will be gone. As we move on our priorities need to be:

Renew: Encourage members to renew, by focusing on their needs within the Legion Family.

Reinstate: Using the resources available find those members who haven't renewed over the past few years, contact them question why and see if you can help with fixing what drove them away.

Recruit: Finding potential members is easy but giving them a reason to want to join us takes a few minutes of your time. Ask yourself, do I know 4 good reasons to join the Legion and can I explain them.

One of the best tools for membership is MyLegion.Org:

myLegion.org is a <u>FREE</u> website designed to connect members of The American Legion to their Post and Department leadership, myLegion includes a site at each level of the organization:

Members - allows members to view information on file at National Headquarters, view messages and events published through the department and post myLegion sites, and network with other myLegion members using networking tools.

Departments - provides membership

information, reports and electronic membership tools such as data change forms for all posts and squadrons within their department.

Posts/Districts/Counties - provides Legion and SAL information for all members in their post. Allows post to submit member data change forms and Consolidated Post Reports electronically. Upload post image, newsletter, message, and calendar. Create membership listings, view members renewing online, search for members who have expired or are members of the department headquarters post, and chat with other officers discussing veteran's issues and sharing membership ideas.

I also suggest that posts encourage every family member to take the Legion Institute Basic Training.

RENEW-REINSTATE-RECRUIT

Children & Youth Fund

First, I would like to thank the Department Commander, for appointing me as you Florida Children & Youth Fund Chairman.

Your Florida Children & Youth Fund committee met at our Department Convention on Thursday, July 5, 2018. The meeting convened at 11:00 am by Chairman John Burroughs. Dennis R. Boland, Jerry Brandt, Tom Soeder, and Bruce Carl were in attendance.

First order of business was a motion to revise the maximum fund range granted to grantees to \$5,000., from \$30,000. Reason was that our funds available would run out within a couple of years and the Children & Youth Fund would become extinct.

Secondly, the applications from grantees would be consolidated to 10 pages adverse to the present 25 pages. This action became effective immediately.

This year we had 6 applications for grants. The actions of the board follows:

SEAGULL INDUSTRIES FOR THE DISABLED

Requested - \$19,060.00
 Rejected the request since funds would go towards staff salaries and travel

JUNIOR LEAGUE OF GAINESVILLE

- Requested - \$5,000.00

Rejected the request because the application did not have the Post recommendation letter.

LUTHERAN SOCIAL SERVICES OF NORTHEAST FLORIDA

Requested - \$5,000.00
 Granted by the board that Post 88 receives the grant to go towards the Backpack for

underprivileged kids.

BIT-BY-BIT EAGLES EQUINE GROUP & HIPPOTHERAPY

Requested - \$10,000.00
 Rejected since funds would go towards veterans and participants above the age of 18.

KIDS SAFE ZONE – AFTER SCHOOL SUMMER PROGRAM

 Requested - \$20,000.00
 Granted \$5,000.00 to go towards food for their different trips. Rejected Van rentals and trip out of state.

ARTHRITIS FOUNDATION – JUVENILE ARTHRITIS PROGRAM

Requested - \$30,000.00
 Granted \$1,325.00 for camp supplies. Did not have a complete breakdown on how the total grant money would be used.

It has been 10 months since Hurricane Irma devastated the state of Florida impacting 70,000 sq. miles with sustained winds of 185 mph, a storm larger than the state of Florida. Homes, communities, whole cities left in ruins. More than 6.5 million citizens returned to the "dark ages" for days, weeks in some

VA Overpayments

As the VA Entitlements Chairman and a Service Officer. I deal with some very disturbing issues, for example when veterans get letters from the VA for overpayments.

There are any number of life events that can result in an overpayment to the VA, and these can result in changes in the amount of benefits you entitled to receive.

It is important to let the VA know whenever there is a change that could impact your benefits. Not keeping these records current can result in an overpayment. When discovered, those funds will be owed to VA, and those can often result in deduction of the monthly benefit amount until the debt is repaid.

Some common overpayment situations are:

- A Veteran receives care at a VA medical facility and fails to pay a required co-pay
- A Veteran fails to report that a school age child has married
- A Veteran receiving education benefits drops out of school
- A Veteran or beneficiary is incarcerated, and benefits are reduced or terminated for period of incarceration

- The Vocational Rehabilitation program purchases a service or tools for Veteran, who then dropped out of the program without a good reason
- A Veteran or beneficiary receiving an income- based pension doesn't report a change in income
- A Veteran change in marital status without notifying VA
- Death of a dependent without notifying VA

If you get a letter from the VA for over payment it is very important to get with your County Service Officer and try to work this out.


