Healthcare for Women Veterans

Women veterans are the fastest growing demographic population serving in the U.S. military. Since FY03, women veterans receiving health care from the VA have nearly doubled from 200,631 to 362,014. These numbers

are projected to grow due to the increasing numbers of women veterans serving in the military.

Women veterans face remarkably different experiences than their male counterparts when they transition out of the military. While VA has made significant advancements in women veterans' health care, there is still room for improvements. When women walk through the doors of the VA it should look like it was designed with them in mind and no longer has the looks of a "For Male only" facility. The American Legion Resolution 147, is to ensure that all women veterans receive gender-specific

quality health care.

Since 2013, The American Legion System Worth Saving Task Force has turned its attention to women veterans' health care. The American Legion wants to ensure that the needs of the current and future women veterans are met. In that vein, The American Legion is encouraging and supporting legislation like H.R. 93, Medical services for women veterans.

H.R. 93 would amend Title 38 to provide increased access to care for women veterans in the VA medical centers. H.R. 93 would require the VA to meet the healthcare needs of women veterans across the VA healthcare system. This bill currently has 18 cosponsors.

Furthermore, through Resolution No. 147, The American Legion has identified a number of challenges women veterans face.

- Many women vets do not identify themselves as veterans
- Many women vets do not know what benefits

they are entitled to receive.

- A Medical facilities across the system do not have adequate baseline plans to close the gender gaps and improve use of facilities and services for women.
- Additional research is needed to determine the purpose, goals, and effectiveness of three VA women models of care on overall outreach, communication and coordination of women veteran's health services.
- Many VA facilities do not offer inpatient/residential mental health care programs for women veterans.
- Many VA facilities do not offer child care services for women veterans seeking health care appointments.
- The excessive time it takes for women veterans to receive results from their mammogram screening.

As these challenges still exist for our nation's female veterans. The American Legion urges Congress to pass legislation to support the healthcare needs of women veterans at the VA medical centers.

State Action on Guns

State Action on Guns:

- **Raise the minimum age.** The bill would change the minimum age for all gun purchases to 21 from 18 — a provision that would have prohibited the Parkland gunman, Nikolas Cruz,

19, from legally buying the rifle he used in his massacre. This is a divergence from federal law, under which people cannot buy handguns from

licensed dealers until they are 21, but can buy shotguns and rifles — often much deadlier than handguns — at 18.

- **Create a waiting period.** Prospective gun buyers would have to wait three days, or until a background check is completed, whichever is longer. There would be some exceptions, including for police officers, members of the military, licensed hunters and licensed concealed carriers. (Members of the Military were not in the original bill). It was added thanks to the American Legion. This includes National Guard and Reservists. If you have a Guard or Reserve Unit near you let them know that we, The American Legion are

looking out for them and members in the future .

GREEN ALERT!!!!

We are current working on a bill what I call: Green Alert!

This is when a veteran goes missing due to any number of reasons. An alert is put out to find and help the veteran. (like the Amber Alert or Silver Alert) We will be looking for sponsors and co-sponsors in the near future. This bill will not come to the house till after the November's elections. I will keep you informed as things start moving forward.

Memorial Day

Memorial Day is a federal holiday in the United States for remembering those who died while serving in the country's armed forces. The holiday, which is currently observed every year on the last Monday of May, will be held on May 28, 2018.

Memorial Day was officially proclaimed by General John Logan, national commander of the Grand Army of the Republic, on May 5, 1868. It was first

observed on May 30, 1868 when flowers were placed on the graves of Union and Confederate soldiers at Arlington National Cemetery. After World War I, the holiday changed from honoring just those who died fighting in the Civil War to honoring Americans who died fighting in any war. Posts will be involved in ceremonies all around the Department of Florida. Whether you participate in a parade, place flags on veteran graves at local cemeteries, conduct a civic ceremony or deliver a speech, be prepared. The American Legion provides a prepared speech suggested by National Headquarters which you can find on-line. The U.S. Flag Code can be found starting on page 157 of the Officer's Guide and Manual of Ceremonies as well as a simple ceremony for Memorial Day which

can be found on page 80 of the same guide. **Please remember that the American Flag flies at half-staff from sunrise to noon, on Memorial Day.**

This year our Commander-in-Chief in his Memorial Day Proclamation also calls for a National Moment of Remembrance at 3 P.M. on Memorial Day.

VA Launches New Claims Appeals Tool

The U.S. Department of Veterans of Affairs (VA) and the U.S. Digital Services have announced their launch of an improved Appeals Status tool to increase transparency and enable veterans to track the progress of their benefits

claims appeals. The tool, which went live March 21 on VA's Vets.gov website, will allow Veterans to access detailed information about the status of their benefits appeals and will include alerts about needed actions, as well as estimates of how long each step of the process takes. Some Veterans who have previewed the new tool said it had given them hope and helped them understand that the process might take longer than expected.

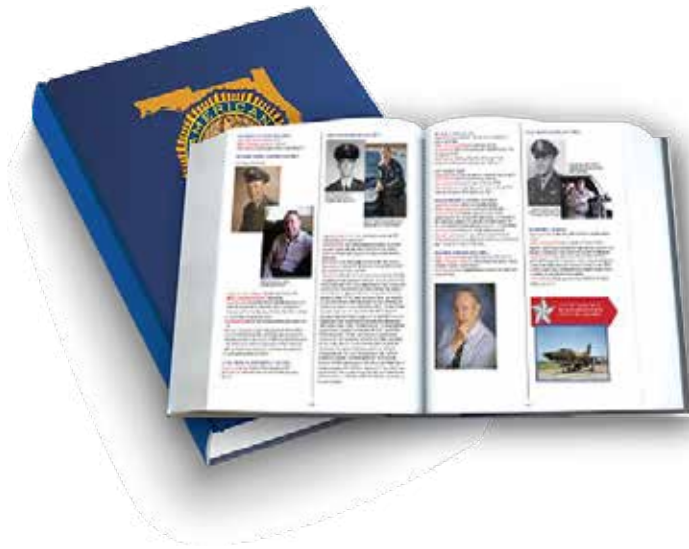

This project was approved by Florida Membership at our 2017 Department Convention and has been approved by the National Headquarters office.

As member privacy is a concern to everyone, it is important to note that member's information will **ONLY be used or printed with their consent**. PCI has entered into a List Protection Agreement with National and as such PCI will only provide your information back to Department Headquarters. The publisher works under a very strict confidentiality agreement and will only use the information provided for the purpose of contacting members to gather data and to sell the directory.

There are 3 parts to the "Member Verification" process:

1. **Update and verify your information** for our records. During this portion, PCI will ask additional questions such as alternate addresses (for snow birds), date of birth, spouse name, etc. This will assist Department in maintaining accuracy in our records.
2. **Opportunity to OPT-IN to the Florida 100th Anniversary Member Directory Publication**. Here PCI will ask the member if they would like to have any or all of the following information printed in our directory: NAME, CITY, STATE, EMAIL, MILITARY STATUS, RANK, BRANCH OF SERVICE, LEGION POST, and WAR ERA. Members must OPT IN and may choose which information is printed in the directory.
3. **Ability to Purchase Directory and Florida Legion Merchandise**. PCI will attempt to sell the member a copy of the book and Department branded merchandise. Purchase is not necessary to be listed.

Every current member will receive a post card over the next few months. PCI will also be reaching out to expired members for the same information and will try to renew their membership, as a part of this call since they must be a member in order to purchase or be a part of the membership directory.

2018 CONVENTION VOTING GUIDE

During the 2017 Department Convention, the membership voted to adopt a new method for voting for Department Officers. All voting for Department Officers will now take place via ballots and scanned with electronic tabulation machines. This will provide a private setting in which to cast secret ballots and expedite the voting process. This guide will provide some pertinent information for the voting process at your 2018 Department Convention.

The annual election of Department officers shall be by special order of business, the results of which should be announced at 1:00 P.M., or as soon as practical thereafter, on the day set for adjournment of the Convention or at the call of the Chair.

Voting for all elected Department Officers shall be by official ballot provided upon registration to any Posts so registered based on paid delegate strength. All official ballots are the responsibility of the acting chairman of each delegation and shall not be replaced for any reason under any circumstances.

How does Department come up with delegate strength? Each Post shall be entitled to two (2) delegates and two (2) alternates and to one (1) additional delegate and alternate for each additional (100) one hundred members provided that the per capita tax is paid fifteen (15) days prior to the Department Convention.

Additionally, according to Section 6, Article 5 of the Department Constitution, a member of the Department Executive Committee shall be a delegate. Therefore, the Post that they are a member of will receive one additional vote.

Each Post will receive one (1) official ballot for every paid delegate at the time of registration with the exception of the Past Department Commander's ballot, which will be provided on the floor at the time of voting as detailed in Section 6, Article V of the Department Constitution. Ballots may either be voted collectively by the acting chairman of each delegation or individually by Post delegates to the Convention. The vote of any delegate absent and not represented by an alternate shall be cast by the majority of the delegates present from the Post.

Those candidates having an endorsement on file at Department by May 30, 2018, will be pre-printed on the ballot. The ballots shall provide for a write-in candidate for each office, should one be nominated off the Convention floor without prior endorsement by their respective Post.

Nominations for Department Officers shall be from the floor of the Convention. Nominating speeches shall be limited to five (5) minutes each. No more than two (2) seconding speeches shall be made for each candidate, each of which shall not exceed two (2) minutes.

Immediately following nominations, ballot voting shall begin on electronic scanning equipment provided by the Orange County Supervisor of Elections. All ballot voting shall be completed by 1:00 p.m. except Posts still in line to vote at that time. Once all the votes have been scanned the election is closed and tally begins.

A team of election officials will oversee the election process. These officials shall consist of an employee of the Orange County Supervisor of Elections Office, the Assistant Department Adjutant, and the Department Assistant Judge Advocate or a representative appointed by the Department Commander in his/her absence.

The election officials will examine any ballot rejections to determine the intent of the ballot. If a ballot reflects votes for two (2) candidates for the same office that ballot will have that one (1) office's vote cancelled and the balance of the ballot cast as presented. Should duplicate ballots be presented, the scanners will reject the votes from both ballots.

The election officials will supervise the vote tally collected by the scanners. The candidate for each office that receives the most votes shall be declared the winner. The results will be placed in an envelope which will be presented to the Secretary of the Convention (Department Adjutant) on the Convention stage to be announced.

In cases of a tie vote, a roll call of Posts for the purpose of casting their votes for the tied candidates shall continue until one candidate receives the majority of votes cast, the roll call is complete or until there shall be only one candidate for a particular Department office.

All official ballots will be retained as permanent record of the Department for a period of two (2) years.

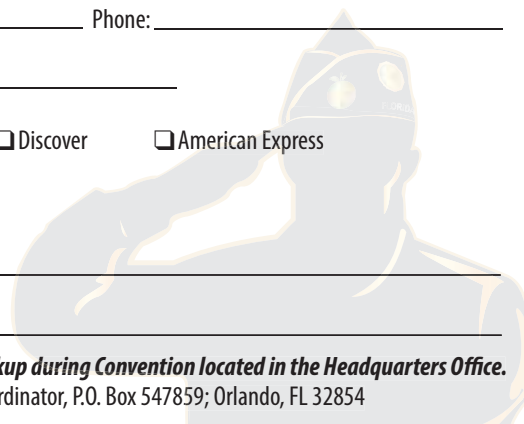
