WHEREAS, At the conclusion of the 2019 Southeast Regional tournament, The American Legion Department of Florida and Tampa Post 248 notified National Headquarters, they would not be able to host the tournament in 2020; and

WHEREAS, The American Legion Department of Alabama and its Baseball Youth Committee has graciously accepted to host the 2020 Southeast Regional tournament; and

WHEREAS, The American Legion Baseball Committee has reviewed the Department

of Alabama's tournament bid proposal and recommends its approval to the Americanism Commission; now, therefore, be

RESOLVED, By the National Executive Committee of The American Legion, by email vote pursuant to Rule 12 of the Rules of the National Executive Committee, That the Region 3 site for the 2020 Southeast Regional tournament of The American Legion Baseball program be awarded to Montgomery, Alabama.

This has the approval of the National Finance Commission, the National Americanism Commission and the National American Legion Baseball Committee.

#### The Rights of Members

Have you ever been in a meeting where you felt frustrated because you were not sure how to participate fully in discussing an issue? Or maybe you were embarrassed because you were told your

comments were out of order. Perhaps you kept silent because you felt you did not know how to make a motion.

Every member attending a meeting

should have the goal to understand the issues and make certain their voice is heard both in debate and in voting. The chairman has responsibilities to make sure members have a fair opportunity to express themselves, but members need to be aware of their rights and responsibilities as well.

In Robert's Rules of Order, you can find the emphasis on the rights of members before the manual of rules even begins. On page li Principles Underlying Parliamentary Procedure it states "These rules are based on a regard for the rights:

- · Of a majority
- Of the minority, especially a strong minority--greater than one-third
- Of individual members
- · Of absentees, and
- · Of all these together

Protecting these right is the reason parliamentary law exists. As a member of an organization you have these general rights:

- To choose to belong
- To be notified of all meetings
- To attend the meetings
- To help influence decision making by making motion, debating, and voting
- To serve on committees

- To have a copy of the society's rules, especially the bylaws
- To help determine dues and how money is spent
- To be nominated, elected, and serve as an officer.
- In addition to rights, members also have responsibilities. General responsibilities of members include:
- To pay dues on time
- To attend and remain to the end of the meetings
- To know and obey the rules of the organization, including bylaws, special and standing rules
- To support and defend the purpose of the organization.
- To know your rights and learn how to use them
- To participate & express your opinions while you are in the meeting when it is in order
- · To observe the rules of decorum in

- To carry out any duty or assigned task or ask to be excused
- To support the decisions of the majority without animosity and further criticism

In addition to these general rules there are many specific rules that greatly empower a single member.

SOME SPECIFIC RIGHTS OF A SINGLE MEMBER (Can be found in Robert's Rules)

- 1. Demand a standing vote if you doubt the chair's announcement of a vote.
- 2. Require the chair to rule when you

- think a parliamentary rule is broken.
- 3. Require the adopted agenda to be followed.
- 4. Change your vote up to the time the result is announced.
- 5. Interrupt pending business if you cannot hear or if there is some other problem related to the atmosphere of the meeting.
- 6. Request a speaker to clarify a statement through the chair.
- 7. Withdraw a motion you made before it is stated by the chair.
- 8. If recognized to speak, the chair must protect you from being interrupted, except in
  - a. cases where interruption of a speaker is permitted.
- 9. Ask for help from the chair to frame a

motion you wish to make or to ask a

- b. parliamentary question on a nondebatable motion.
- If you are the maker of a motion, you have preference in recognition to speak first to
  - c. that motion.
- 11. May call another member to order when that member repeatedly questions motives
  - d. of other speakers or persists in speaking on irrelevant matters.
- 12. May abstain from voting and cannot be compelled to vote.

This should help you to enjoy participating in the business meetings of your organization.

A Certificate of Appreciation is being sent out to all the Posts through the Membership Chairmen and District Commanders that have made their 100% mark before May 31st, as a thank you from PDC

Ramos and myself. We currently have 45 of them. Thank you.

I want to take a minute to acknowledge all the Posts that have been making their monthly goals. As you know we should be at 85% as of February 5th and our March 4th goal is 90%. We always have to keep in mind that with larger Posts (Post memberships over 1,500 members) it is harder to get that one percentage point than the smaller Posts. I've learned a lot about our Posts in the Panhandle and in the South because geographically they so far from the rest of the District. Recruiting is quite the challenge. I think we're all doing a great job but we can't sit back and relax yet. There are 1,440 Post 400 members that have NOT renewed as of the February 13th report. I encourage Posts to continue to work the DMS lists and Buddy Checks. We're two and half months away from the 100% goal; I know we can make 103%. As of today, Department of Florida is at 90.54%

We are also making an initiative to participate in Yellow Ribbon events with our deploying and returning troops. This command is out of Ft. Jackson, SC and they will be contacting me with their schedule. The events take place in Orlando. For those of you that are not aware of this program, various vendors assemble much like at convention which gives the American

Legion the opportunity to communicate one-on-one and speak during their general assemblies. Rob McGregor from Post 5 and I have conducted many of them. For some reason, the American Legion lost a seat at that table. We look forward to helping these troops and to recruit as many as we can. It would be great to form teams to work these events.

At the 2019 American Legion national convention, the keynote speaker, US Secretary of State Mike Pompeo, spoke about the state of "Americanism" in this country. What I took

away from that speech is that the word "Americanism" has come to be known, in a growing segment of our country, as a divisive word. This is unacceptable!

Americanism reflects the attitude and belief that this country is founded on principles that all men are created equal and have the right for life, liberty and the pursuit of happiness. But for some reason, politics has taken over almost all aspects of our society and transformed what used to be discussions that ended in compromise or at least a better understanding and have turned into 'Contempt" for those who disagree with you.

One of the greatest things about our country is the ability to disagree without fear of persecution. Whether you're on the left, the right, or in the center, it shouldn't matter because at the end of the day we all are Americans. If we always maintain respect the other person, we can learn from the experience of an intense

discussion. Respect is maintained when we are able keep contempt out of the picture. Because, at the end of the day, we are all Americans.

So if your post is on the list to be visited (to be provided later), we ask that you collect the flag grommets and/or do your flag retirements while we are there. Note: We are currently working with a local artist to come up with some conceptual designs that respectfully honor what those retired flags flew for. More details to follow in the coming weeks.

The American Legion, Department of Florida a few years ago to assist foreignborn U.S. veterans on Immigration issues. During my tenure as the Department's Immigration Committee Chair, many

of the cases I worked, the veteran states he/she believed citizenship came automatically for serving on active duty and receiving an Honorable Discharge when the military obligation was complete. As Ms. Ricci states in her article, completing service in the US Military does not make one a citizen. There are perhaps thousands across this country whose stay and family existence could be in jeopardy. Read Ms. Ricci's article and pass on her suggested tips for obtaining citizenship by those foreign born who have served in the US military were honorably discharged.

Foreign Born Vets Face Surprises En Route to Citizenship: Tips for Success By Elizabeth Ricci\*, Esq. What does it take to become a citizen of the United States? Despite what you might believe, not military service.

Many foreign-born veterans erroneously believed that their military service automatically made them citizens, either because they were promised by highranking officials that they would be made citizens or because both the oath of enlistment and the naturalization oath confusingly contain the same pledge to "support and defend the Constitution of the United States against all enemies, foreign and domestic; [to] bear true faith and allegiance to the same." In order to become a naturalized US citizen, however,

Immigration - continued from page 9 an applicant must generally be a Lawful Permanent Resident ("Green Card" holder) then affirmatively apply for citizenship.

Some of the 645,000 foreign-born veterans of the US Armed Forces receive the surprise of a lifetime when they learn, usually upon application for benefits at Social Security, at their local DMV or passport office, they are not actually citizens.

Since knowingly holding oneself out as a citizen is a bar to naturalization, USCIS officers often erroneously deny vets' Applications for Naturalization for having participated in our democracy by voting or having registered to vote over a misunderstanding about whether the voting was done "knowingly". Such poor decisions cause vets to have to appeal.

Vets, including those who registered to vote or voted, may overcome the Green Card prerequisite if they served during a designated period of hostility (World War II, Korea, Vietnam, Persian Gulf and Enduring Freedom) or made "extraordinary contributions to national security". Without such, they may need to become Green Card holders (through US citizen or Permanent Resident family or as refugees, for example).

Australian-born US Marine Corps veteran

Paul Canton of Summerfield, Florida finds himself in a unique predicament. He was told by his recruiter in 1991 that his service would make him a US citizen. Upon his honorable discharge in 1995, he believed himself to be a US citizen and voted in several elections. Imagine his surprise when he went to renew his driver license and was told he was not eligible to do so. He guickly contacted USCIS where an agent told him to file for naturalization. When he appeared at the Orlando USCIS office, the interviewing officer told him, "I don't know how you got into the country; I don't know how you got into the military, and I don't know why you are still here" and denied his application claiming he had poor moral character for having voted. The case is now on appeal. Meanwhile, he is a man without a country as his US military service caused his Australian citizenship to be revoked, leaving him stateless.

It is important to note that the application process is not the same for veterans as other would-be citizens. Although foreign-born veterans still file Form N-400 they must also file Form N-426, Request for Certification of Military or Naval Service, (both forms are available at uscis.gov), and provide a copy of their DD-214 with two passport style photos. All vets' applications are mailed to USCIS in Chicago. Vets are not required to pay naturalization application or biometrics fees. In some jurisdictions, eligible veterans may request

that they naturalize the same day of their interview which consists of speaking, reading, and writing in English as well as civics questions. Denials may be appealed via Form N-336 without fee.

Veteran naturalization applicants, especially those who voted or have other criminal histories, should seek legal help from an experienced immigration attorney or a Service Officer with their local American Legion or Veterans of Foreign War post.

The Army's MAVNI program (Military Accessions Vital to the National Interest), however, granted expedited fast-track citizenship to multi-lingual non-Permanent Residents with high demand skills who enlist. The program, has been essentially been put on hold. AILA InfoNet Doc. No. 130092060.

A federal ruling on December 12, 2019 that held anyone born in American Samoa should be recognized as a U.S. citizen was put on hold until the issue is resolved on appeal. American Samoan vets need not be Lawful Permanent Residents to naturalize but must live in another part of the United States in order to apply for citizenship


