


There are even some posts that have reached out to us during our visits for help with the Legion side of the house for training in membership, program initiation and protocols. This is the area where we all must strive to be the same.

The American Legion assists families of U.S. military personnel who have died or became disabled while serving on active duty on or after Sept. 11, 2001, by providing college scholarships for their

children. The program expanded in 2017 to include scholarships for students whose post-9/11 veteran parents have been assigned a 50 percent or greater combined disability rating by the VA.

The American Legion Legacy Scholarship

Fund was established by the National Executive Committee in October 2001. Since the fund's inception, more than 366 scholarships have been awarded, generating tens of thousands of dollars for students. The American Legion Legacy Run is a major contributor to the fund, often raising more than \$1 million a year.

Throughout our fifty-five (55) Departments, the American Legion Riders have made this program one of their special charities. Legion Riders in all Departments have consistently raised money for this worthwhile charity. Also, the American Legion Riders annually conducts the American Legion Legacy Run, a crosscountry multi-day motorcycle event. As many as 500 participants ride more than

1,000 miles from a predetermined starting point, ending at the national convention city.

With the American Legion Legacy Run, and INSTATE runs raising money for the Legacy Scholarships, the Legion Riders have raised over \$16 million nationwide for the Legacy Scholarship.

In 2019 \$1,122,624 Legacy Scholarships Funds were awarded to fifty-seven (57) children. Since 2001 to 2019, 366 Legacy Scholarships have been awarded. Total funds awarded since the Legacy Scholarship inceptions is \$3,031,633.

If everyone followed the CDC guidelines the task becomes a little easier but it is still not a guarantee that the virus will not invade our spaces. As Commander of Post 275, even with our stringent following of the rules we still fell victim to an outbreak that required us to shut our doors for an entire week. The real problem is we don't know where

it is coming from. Most of our patrons travel around within the community and socialize wherever they go. Even a trip to the local grocery store can result in someone getting sick. As a result, we purchased two Vollaro Air Purifiers. These units turn oxygen into Hydroxide vapor which coats all surfaces and kills the virus on contact. They are used by NASA and many other public places. It reduces the need to continually wipe down everything after a patron leaves.

On a much happier note, the Oratorical contest for Department was a great success. Meri West did an awesome job, and the contest produced a truly knowledgeable champion. As we try to recover some sense of normality, it's programs like this that brings us back to the missions we work so hard at especially in these difficult times.

At this time of the year with many of our members have already paid and the virus remains an issue getting those remaining people to pay their dues is even harder. I want to commend the 15th District Commander for his diligence and hard work to get his district once again to the top. Great job Commander Carl the last lap of the race is around the corner and I expect that you will cross the finish line first.

Again, Thank You for all your Efforts! Here is our tentative schedule for the balance of the year for your review and comments.



Washington Conference Week Virtual Meeting

As a member of the American Legion National Veterans Affairs and Rehabilitation Council, I attended the Washington Conference Week virtual meeting that was held on March 2, 2021. One of the guest speakers was Thomas Murphy, the Acting Secretary for Benefits in the Department of Veterans Affairs.

Secretary Murphy explained VA Secretary Denis McDonough's three core VA responsibilities. 1. Provide timely world-class healthcare. 2. Access to benefits veterans have earned. 3. Honor our veterans with a final resting place.

He also informed us that during the first quarter of Fiscal Year 2021, the VA Benefits Administration (VBA) distributed \$31 billion dollars in benefits. The following explains some of the recent milestone accomplishments of the VBA's different service areas:

- The Veterans Readiness & Employment Service formerly known as the Vocational Rehabilitation and Employment Service paid nearly 390 million dollars to 59,000 program participants.
- 6 million Compensation & Pension Service exams were completed under VBA contracts.
- The Pension & Fiduciary Service paid 1 billion dollars in pensions to 539,000 veterans.

- 4. Insurance Service provided 1.2 trillion dollars in insurance coverage to 5.6 million Service members, Veterans and family members.
- Home Loan Guaranty Service guaranteed 112 billion dollars in housing loans for nearly 400,000 Veterans.
- 6. Transition & Economic Development Service reached out to more than 82,000 Veterans through VA Solid Start.

No Angel is a book currently on the New York Times best sellers list by Jay Dobyns. Retired ATF Agent Jay Dobyns states, "I infiltrated the Hells Angels Motorcycle gang-and ever since I've

been on their hit list". Law Enforcement Today interviewed with Retired Agent Dobyns regarding his exploits. Excerpts from their interview and the book

No Angel are as follows:

Being a Law Enforcement Officer is challenging- sometimes very challenging. And once in rare while, as challenging as you could ever imagine. But Jay Dobyns story is anything but imagination. It is one of true, extraordinary heroism and off-the-charts dedication to duty.

Jay Dobyns retired ATF agent, is most known for his undercover (UC) work in Arizona infiltrating an ominous group of outlaw motorcycle thugs known as the Hells Angels. In April 2002, an infamous deadly brawl broke out in a civilian packed Nevada casino between two warring motorcycle clubs-the Mongols and the Hells Angels. This prompted Federal Law Enforcement Officials to open and investigate this threat to Society. And they knew just who to go to-Jay Dobyns.

By this time Jay has already been with ATF for well over a decade and had been on countless undercover operations. Being intelligent and quick witted, and dedicated to Law Enforcement, he was the perfect fit for this daunting task

As he made his way through Operation Black Biscuit infiltrating the Hells Angles, he started earning the trust of several high-ranking members, even befriended them. But he always knew where to draw the line.

Jay said," While UC I developed close, personal relationships. There is no doubt in my mind that while in a role, some of the suspects that I had befriended would have stepped in front of a bullet for the Jaybird. But I never lost sight of whose team I was on."

If Jay was to be successful in infiltrating this dangerous gang, the UC life would have to take priority. His character, Jaybird, had to come first-even ahead of his own family. However, that came with a heavy personal price.

"This is my biggest regret in life. My UC role became more than what I did, it became who I was. That is very dangerous. I am humiliated to now have to admit that I abandoned and betrayed my own wife and kids in exchange for some false, hero-worship legacy that never came true."

"On one occasion I came home, and my wife Gwen told me "You can't just show up at this house and speak to me and the kids like we are your people on the street." Jay stated. "That was the harsh truth of how I was treating my family."

Jay tells LET that after two years inside the Hells Angels and collecting several indictments against several gang members it was time to leave the Angles which required him and the other UC Agents to commit such offense that they would be banned from the Angels.

"I was in a bar trolling the Sons of Silence (MC) in Colorado with an amazing team of UC agents. Our goal was to create a confrontation, be ordered to remove our fabricated gang clothing (aka colors), and leave town. The (SOS) found us in their bar! The critical threat was delivered and recorded, and the case was made."

That is when Jay and the other UC agents

were expecting to leave: Jay explained, "I overstepped. They outnumbered us 5 to 1. The right move was to follow their orders. But no, I started a massive bar brawl that resulted in us being locked inside and having the crap beat out of us with pool cues and brass knuckles until the became bored with kicking our asses."

They we're finally out of the club and returned to the Agency. (ATF) Several of the Hells Angels went to prison due to the agents efforts.

Jay Dobyns is now retired and coaching the Tanque Verde High School football team in Tucson, Arizona.

Jay also mentioned the current struggle facing Law Enforcement today and offered this inspiring message to the LEO community. He said," We are underappreciated, who go underpaid to do the unthinkable for the often ungrateful. They report for duty knowing that they will be hated, despised, ridiculed, filmed, taunted, spit on, assaulted, sometimes murdered...and they still do the job."

American Legion National Veterans Affairs and Rehabilitation Council Virtual Meeting

The Annual Washington Conference Week meetings were conducted through Zoom meetings this year. As a Florida member of the American Legion National Veterans Affairs and Rehabilitation Council, I attended the

March 2, 2021 virtual meeting.

Dr. Richard Stone the Acting Under Secretary for Health, Veterans Health Administration (VHA) gave us an update on the VA's response to the COVID-19 virus. Over one million veterans have received the COVID-19 Vaccine which is roughly 20% of all veterans. The VHA staff have stepped up and volunteered to go where they were needed the most to support both VHA and civilian healthcare facilities. The pandemic identified the Just-In-Time Supply system was not adequate to provide the required medicine, medical supplies and personal protective equipment that were required to fight the pandemic. The supply chain has been modernized to ensure necessary supplies are always available. The VA has used 3-D printing to produce masks and other medical items. Tele-help lines have been expanded by 1,800 % resulting in

200,000 visits each week. The Cares Act Funding gave the VHA 17 billion dollars. The funds have been used to add 80,000 additional staff members, buy Covid-19 test kits, set up mobile medical facilities and to provide grants and pensions to help prevent veterans from becoming homeless during the pandemic.

I also attended the Cemetery subcommittee virtual meeting.

Did you know the Omnibus bill of 1862 authorized President Lincoln to purchase grounds for use as national cemeteries? Prior to this bill, soldiers were buried where they fell. Fourteen national cemeteries were established in 1862. Currently the National Cemetery Administration (NCA) has 155 national cemeteries comprising of 9,245 developed acres and provides perpetual care for 4.84 million veterans and family members.

The NCA in 2016 established a Veterans Legacy Program (VLP) that commemorates our nation's Veterans through the discovery and sharing of their stories. VLP encourages students and teachers at the University and K-12 level around the country to immerse themselves in the rich historical resources found within NCA national cemeteries. Participants research Veterans interred in national cemeteries and develop educational tools that increase public awareness of Veteran service and sacrifice. Do you know a veteran that is buried in a national cemetery? Would you like to post a short comment, memory or story about the Veteran? Just go to https://www.cem.va.gov and click on the Veterans Legacy Memorial tab. A search box will appear. I found it is best to use just the last name to do the search unless the last name is very common. Once you find the veteran's name scroll to the bottom of the profile page to enter your comment, memory or story about the veteran.

The VA Benefits website https://www.benefits.va.gov/benefits is constantly changing. Make sure you review the website periodically to ensure you are receiving all of the benefits you are eligible for. Also ensure your family reviews this site to ensure they know where to find information they might need in the future.

While our hospital and CBOC reps still aren't able to resume their normal volunteer duties, some volunteer positions are being phased back in, some of our VAVS reps have joined with their respective facilities and are participating in Buddy Check and Compassionate Contact programs. Should you have as little as one hour per week to

volunteer for this, contact your nearest VA hospital.

I'm proud to say that even under current conditions our Post Service Officers continue to team up with County and FDVA Service Officers to continue to help our fellow veterans with claim and benefit information as well as a host of other services. Legion Post Service Officers have been instrumental in veterans receiving awards of approximately fourteen (14) billion dollars. Additionally, let's remember that Post Service Officers' responsibilities make them a valuable resource for many other services community-wide.

With the American Legion lending it's strong voice in support, the VA has established it's Center for Women Veterans. Through that program, both active-duty servicewomen and women veterans can easily access information regarding health services, the process and eligibility for enrollment and connecting with other women veterans. Veterans can access this information at: www.womenvet/ docs/whtt/VAwhttParticipantHandbook.

A word of caution to veterans and/or their families who are considering filing compensation and/or disability claims. Do NOT fall victim to any offers by any person or entity other than those recognized by the VA. Many will "guarantee" results and charge fees for their service. There has been an increase in fraud and scams in this area. Be aware that no authorized individuals ever charge for their services.

Lastly for this month, we should band together and contact our Congressional

representatives to re-introduce the Toxic Exposure in the American Military Act. This addresses toxic exposure and Burn Pits for Post-9/11 veterans. As so many Vietnam veterans are aware, it took over twenty (20) years for Agent Orange exposure to be recognized by the VA. Our younger brother and sister veterans are now facing the same fight. Let's help them.


