to thank Post 63 for the generous \$30,000 donation to PVR from their Challenge 22 event. We also have Post 359 raising funds all the month of January for PVR. They raised over \$15,000 last year. All these funds have been assisting the veterans in Florida during these challenging times.

Thank god for PVR and what the program does. From March through December of 2020, PVR assisted 273 families with over \$225,000 in COVID assistance claims.

The vaccine is finally out, and hopefully, this virus will be slowed to a crawl letting us get back to somewhat normal operations. During Post visits, I'm seeing great things that have been and continue to be done around the state. So many posts have found ways to move forward despite the ongoing health crisis. 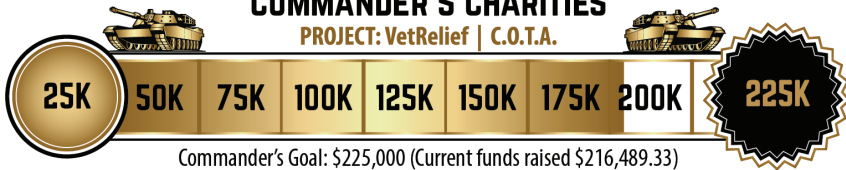
get back on track. Thank you, Stuart Scott some of the other District Commander and Vice Commanders, for volunteering to assist in this endeavor.

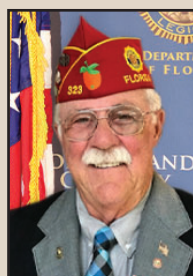

through amateur radio.

The American Legion National Headquarters station was established in 2011. Under the FCC call sign K9TAL, the club operates as a "special-event" station on Veterans Day and The American Legions' birthday, trading shortwave calls with amateur radio operators worldwide. TALARC members also run regional and national practice radio nets over a

Do you or a veteran you know need a mobility scooter?

The American Legion, Department of Florida received seventeen mobility scooters earlier this year from generous donors, Jack

Kump and his wife, Joan Wheeler. Their donation has already made an impact on veterans who have received one of these high-end scooters. We still have a few mobility scooters remaining that need to be distributed to well-deserved veterans.

If you, or a member of your Post, are a disabled Florida Veteran, who could greatly benefit from one of these mobility

scooters, we would like to hear from you.

Requirements:

- Must be for the use of the veteran applying.
- Veteran must be a Florida Resident.
- Provide proof of military service.
- Have the capability to arrange pick up of the scooter at Department Headquarters in Orlando, Florida.
- Written explanation of need.

The American Legion, Department of Florida asks that you write a letter or email explaining why you, or a known Legionnaire, should receive one of these scooters. Briefly discuss why you feel you, or they, should be chosen. Please include a copy of your DD214 to verify your veteran service and be sure to include contact information. **All letters and DD214 forms must be received in our office no later than February 26, 2021 for consideration.** Late and incomplete

submissions will not be considered. Please do not call for inquiries, recipients will be decided by a Department Committee based on the written entries received by the deadline, and on a first come first serve basis.

**All entries should be mailed to:** The American Legion, Department of Florida, Mobility for Veterans, PO Box 547859; Orlando, FL 32854-7859 or via emailed to [jcooper@floridalegion.org](mailto:jcooper@floridalegion.org). Selected recipients will be notified in March to start arranging pickup of their mobility scooters.

*Retiring Flags and Brass Grommets*

Americanism: Nothing more signifies Americanism to me than the flag of our country. Flying proudly, it represents so much - including the symbolism of freedom, our way of life, and a

reminder of the sacrifices and bloodshed by those who serve to defend her. Wouldn't it be great to see every house on your street or business in your town flying it proudly? This is where you at the Legionnaire can play a significant role.

After a while of flying proudly and working so hard to represent the USA, our

flags become tired, tattered, and torn. It then comes time for the flag to be retired. The US flag code dictates that the flag must be destroyed by burial or by burning in a dignified manner. Does your American Legion Post retire flags? Many Posts offer this type of service to your community. Do you collect them from the community and/or have others retire them for you? Or do you retire them yourselves? Do they need to stop by when you're there or can they drop them in a mailbox outside your Post? If so, great! If not, please consider doing this today. Whatever you are doing, I ask that maybe you take two extra steps.

The first step is an additional service to the community, but also can turn in to a money-maker for your Post. Here's how! Ask yourself the question, "**if someone is willing to go to the effort of driving to**

**your Post to drop off a retired US flag, then wouldn't they be more than willing to buy a new US flag from you if you could offer it to them easily?"**

Through Emblem Sales, we have American flags that are very high-quality, made in the USA and where all the proceeds go directly towards supporting veterans who have served. A little-known fact is that Emblem Sales will give your Post a credit in the amount of 10% for all sales made each year. Use those funds to buy more flags. Then apply the proceeds from those sales towards American Legion programs.

For example, if in 2020 you sold \$4,500 worth of flags, your Post would get a \$450 credit at the end of the year. This is the same amount it cost to send one Delegate to Boys State each summer. So why not attach an order form to the collection box so that those who are dropping off can place an order for a new one? Then 1-2 times a month you can hand-deliver the new US flag to whomever bought it.

This way you can personally thank them for supporting the American Legion and possibly recruit a new member.

The second step happens when you retire a flag by burning. You see, once the fire is out, all that is left behind are the ashes and the brass grommets that once held the flag to the pole. Typically, these are swept up and thrown away. But here in the Dept of Florida, we have a campaign to collect all the burned/retired flag grommets. The idea

is to gather as many of these as we can each year, so that they can be ultimately be melted down into something of value. Imagine a beautiful brass piece of art made of retired US flags that can be awarded each year as a traveling trophy to the Post with the Best Americanism program or maybe a beautiful brass monument to be displayed at our Dept HQ made from the melted grommets. Please start collecting those grommets from your fire pits today!

What better way to start out than to show you a testimonial about a Mother and her Daughter, Selena, from St. Cloud, FL.

"I have been a blood donor since 2009, when my soon-to-

be mother-in-law passed away from Leukemia and I began donating blood to honor her. I discovered at that time that I have one of the rarest blood types, so blood donation became a necessity for me, not an option.

But the reality of just how much blood donation can change lives didn't really sink in until April 2020, when my 5-year-old daughter was diagnosed with A.L.L. Leukemia. After about her fourth

transfusion, it hit me hard: my child needs this blood to survive, and if she doesn't receive it, she will die.

I stared at the bag and realized it came from OneBlood and marveled at the fact that some stranger had donated that blood just a few days ago, and now here it was, saving my child's life.

The tangibility of that donor's sacrifice, as well as my own when I donate, was not at all lost on me: blood donation LITERALLY saves lives, and I got to see firsthand just how important of an act this is in the case of saving my own daughter's life".

That could be any of us one day!

COVID Update!

On a personal note, I got my 1st shot of the Moderna Vaccine which I'm very fortunate to have, now the second one comes 21 days after. This was not only important to me for my family's sake but for my work to the American Legion at my Post and as

your Chairman.

Without getting political about the whole thing, this is a massive operation in the State of Florida. Releasing the authority to run the vaccination distribution down to the County level has created quite a cluster. Out of state visitors receiving vaccinations ahead of our residents. Long waiting lines, website and call-in sites breaking down. All I can tell you is be persistent if you want the vaccine. Of course, in Florida you have to be 65 years old unless you're a frontline worker or law enforcement among others.

Please don't forget the Covid-19 Convalescent Program that takes the plasma from recovered Covid-19 patients and is used to treat new patients. Two of my friends made it out of the hospital that were given this treatment. You can ask One Blood if you are a candidate to give if you have already contracted the virus.

The Broward County JROTC Program Accreditation (JPA) Annual Reviews were held the second week in January. These reviews are held every three years on a rotating basis in Broward County by the 6th Brigade Command. Due to the COVID-19 restrictions in Broward County, this was a virtual event conducted by the higher headquarters administrator, Max Denniston. I had the opportunity to be in attendance for three of the interviews. The review covers the program goals throughout the semester to keep the cadet programs on track. The Cadet Battalion Command under the leadership of the Cadet Battalion Commander, gives the Continuous Improvement Plan (CIP) Brief to the Review Panel. The first review was at Cypress Bay JROTC and the Cadets were very well prepared and did an outstanding job on showing the program advancements during the semester and the focus on "Winning Colors" designed to help each individual cadet understand their own personality strengths and weaknesses and that of others that they are dealing with.

The Cadets are very active in the community with parades and volunteering

and gain community service hours as well as recruitment with middle schools with a video promoting focus on robotics, STEM, mentoring and tutoring. The motto of the JROTC Program is "to build better citizens" which is the foundation of the Cadet Program. Kudos to the Battalion Commander, Justin Torres and his leadership and may he be successful with his career and appointment to West Point. Another segment of the JPA is the Service Learning Project Briefing. The basis of the program is what you learn by personal growth and a better respect of what someone else is going through. To see through someone else's "eyes". In this time of the COVID-19 pandemic, this can be shown to enhance personal growth and an empathy for others. I had the opportunity to attend two programs and was very impressed with the Cadets' selections.

Plantation JROTC Cadets chose a "Harvest Drive" for the community. The Cadets planned, shopped, collected, packed, sorted, and distributed food and hygiene products for 180 families. The experience demonstrated learning goals of leadership and self-improvement along with time management to conduct the massive effort. This was a team effort and was under the organization of two Cadets who coordinated the project.

Marjorie Stoneman Douglas JROTC Cadets, Continuous Improvement Plan Brief had a focus on the Retainability of the two Cadets. Their goal is to increase participation and retention for the growth

and future increase in the numbers for the program for future years. For the Service Learning Project the Cadets choose care packages for the Alexander "Sandy" Niningger Veterans Nursing Home. This program was coordinated by two Cadets with a team effort to plan, shop, gather, and deliver items to the Nursing Home for their goal of 84 residents. This number however increased as they were able to get more than the planned items. The Cadets also included personal handmade cards for each package. This demonstrated the idea of the Service Learning Program which taught the Cadets empathy for the veterans who at this time are isolated and lonely and not able to go out as some normally do, or have the busy schedule of the Nursing Home with guests and entertainment during the Holidays. I would encourage our Legionnaires to get an opportunity to attend one of these Annual Briefings and see how well the Cadets coordinate and present this very important part of the Legion Four Pillars. You will not be disappointed.

## 2020 Was a Bad Year for Law Enforcement Officers/First Responders

The coronavirus pandemic has been responsible for more police officers' deaths in the line of duty than any other cause combined, according to a nonprofit dedicated to fallen police officers.

According to the Officer Down Memorial Page, 101 police officers across the country have died after contracting COVID-19 while on the job. Eighty-two other police officers have been killed by other causes in the line of duty in 2020.

A second nonprofit, the National Law Enforcement Officers Memorial Fund (NLEOMF), lists 110 officer deaths linked to COVID-19.

Both Officer Down and NLEOMF only count officers who were known to have

contracted the virus while in the line of duty and they review each case before adding it to their count. Officer Down says it is reviewing an additional 150 fatal cases of COVID-19 that may be added to the count in the future.

"By the end of this pandemic, it is very likely that COVID-19 will surpass September 11th as the single largest incident cause of death for Law Enforcement Officers", Officer Down executive director Chris Cosgriff told The Washington Post.

Officer Down reports that seventy-three police officers died on September 11, 2001 in the terrorist attack on the World Trade Center, and more than 300 have died of Cancer linked to recovery efforts in the years since.

According to NLEOMF, the state with the most police officer deaths linked to COVID-19 is Texas, where twenty-four officers have died since the pandemic began. Another twelve have died after contracting the virus in nearby Louisiana. Officer Down also reports that non-

coronavirus related police officer deaths in the line of duty are down in 2020, despite widespread civil unrest. Thirty-one police officers have died from gunfire this year, the second-leading cause of death among officers in the line of duty. Another four officers have died as the result of "Inadvertent" gunfire.

President Donald Trump earlier this year, signed the Safeguarding America's First Responders Act of 2020, which offers federal benefits to the families to police officers/first responders killed by COVID-19.

Legionnaires, please pray for these police officers, sheriff deputies, fire fighters, paramedics, and their families and thank them for their sacrifice. Remember many of these who have passed were military veterans and many still with us today still doing the job where who knows what 2021 holds for them.

During times of political upheaval and unrest, we often fall back on our Constitution to help make sense of what is going on around us and what action to take.

Certainly, the Coronavirus pandemic has raised a host of constitutional questions such as:

- **How states and the federal government respond in a crisis.**
- **How far reaching should emergency presidential powers be.**
- **How and if voting procedures should be changed.**
- **How and when we should sacrifice personal freedom for the common good.**

In colonial America, quarantines were frequently used to isolate people with malaria, typhoid, yellow fever, and cholera. One reason there were so few Supreme Court cases about it is because most people accepted that it was for the good of society and did not think to challenge it.

Generally, states were left to figure out and manage the quarantines and other public health issues. In 1904 though, the Supreme Court weighed in on a case, *Jacobsen vs. Massachusetts* where the state was requiring a smallpox vaccination to protect its citizens. The court ruled that the danger of smallpox to the community greatly outweighed the individual dangers that a vaccine might cause.

The court affirmed the right of the state to endanger individuals for the benefit of society.

Faced with our current public health

epidemic, the Supreme Court decision about the government's power to protect citizens by quarantine and forced vaccinations will likely receive renewed interest in the coming year.

I wanted this article to have a focus on how understanding the Constitution is relevant today, even though it was written in 1787. The pandemic was a good example of showing how the interpretation of the Constitution affects our daily lives. I wanted to remind the Legion Family that the purpose of the Oratorical contest is to encourage students to have a greater understanding of our governmental processes, a more thorough understanding of the Constitution and a forum to practice and hone their public speaking skills. Aside from winning money for college, the experience of participation in this contest is priceless.

Then there was a siege on the Capitol on January 6th, 2021.

But wait...was it a siege? Was it a protest? A riot? An insurrection? An attempted coup? A rally? An assault? A storming? Was it a rebellion? Or an uprising? Or a revolt? Was it domestic terrorism?

Words matter. We may not agree on what to call the January 6th event, but we can agree that our choice of words matter.

If you are a fisherman out on your boat, you need to know if the motion of the ocean you are feeling is a wave, a current, a tide. You need to know is it a high tide, low tide, neap tide, spring tide. If the movement is a storm surge, an upwelling or down welling, a rip current or longshore current. Is it a capillary wave, gravity wave, deep water wave, trans tidal wave? Or worse, is it a cyclone, tsunami, gyre, or seiche? Your life may depend on knowing the precise word to describe your situation so you can take the best action to prevent disaster.

If you live in Los Angeles and you feel

a rumbling under your feet but the man on the news said there is a herd of bison storming Rodeo Drive, you might continue shopping. But if the man on the news says it's an earthquake, you will take a whole different course of actions. Words matter. Be precise.

Aside from capsizing on the rough seas or getting trampled by a herd of bison looking for sales on Rodeo Drive, language is a critical component for an effective leader. How we structure a question, make a statement and word choice has meaningful impacts on the people who we are speaking to.

The Oratorical contest helps us teach students the craft of speech writing where they can practice their choice of words and get constructive criticism from the experienced and skilled public speakers who are judging the contest.

I watched an Oratorical contest once where one of the students was using the term "illegal aliens" to refer to people trying to enter the United States. He used the word repeatedly. One of the judges was a woman of color. (Here is an example of a word choice I have to make, I could say she is bi-racial, a woman of color, black although she is light skinned.

To me it is not important what her skin looks like but if you are giving a public speech you should know your audience.

If all you see are alabaster faces in your audience, you may use different language than if you see a variety of skin tones in your audience. Turns out this lady was the child of a black father who was a civil rights icon and a white socialite mother from Russia).

After the contest, she was giving feedback to all the students and I overheard her tell him she felt his use of "illegal aliens" could be construed as offensive and that she thought going

forward with this speech he should use other terms such as undocumented person or undocumented migrant. We don't expect students to know all of this but taking note of who your audience is can help you decide on the best words so that you have a winning speech as opposed to a mediocre one.

That student might end up being the mayor one day or a physician, but I feel certain that he will be more cognizant of his choice of words because of our Oratorical contest. It's a big thing and as chairmen, you should feel proud of your efforts in supporting this contest.

When I started this article for the

Legion Link, my focus was primarily on the pandemic and Constitutional questions that arise from the public health standpoint.

The siege on the Capitol raises a whole other list of questions we look to the Constitution to answer.

- **Can the Vice President invoke the 25th Amendment to remove the President from office?**
- **Were the President's words and actions or lack of action inciting violence?**
- **Is the Twitter and Facebook ban an infringement on his 1st Amendment rights?**
- **Can the Senate convict an**

**impeachment after the President leaves office?**

- **Are the digital photos and selfies taken at the riot tantamount to virtual confessions to law enforcement?**

Again, the Oratorical contest provides students with an opportunity to study the Constitution as a living document and in a contemporary way. And then they can showcase their knowledge and understanding in a contest. It is truly inspiring. It's been a rough year for chairmen with the pandemic. It's hard to reach all the students in a good year, but we managed and soon you can enjoy the fruits of your labor at the Department contest! Many thanks all around!

The VA is beginning COVID-19 vaccinations at 128 additional sites. VA will begin Moderna and Pfizer COVID -19 vaccinations this week at those additional sites. **The process for getting appointments for vaccination are**

**ever changing so pay attention to county and municipal news regarding the process.**

On Dec.18, the U.S. Food and Drug Administration (FDA) issued an Emergency Use Authorization of the Moderna COVID-19 vaccine, which is the second COVID-19 vaccine to be authorized.

"Having a second COVID-19 vaccine will enable us to reach more facilities and vaccinate more health care personnel and veterans in additional parts of the country"; said VA Secretary Robert L. Wilkie. "We continue to implement our COVID-19 Vaccine Distribution Plan and are grateful to be one step closer to seeing the end of this pandemic."

Per Centers for Disease Control and Prevention (CDC) recommendations, the VA will continue to vaccinate health care personnel, as well as community living center residents and spinal cord unit residents.

113 VA Medical centers (VAMCs) and outpatient clinics will receive limited Moderna COVID-19 vaccine supplies this week. Here are the ones in Florida:

Now that the holiday season has passed, let's look forward to what we hope will be a better and healthier new year. Let us remember that the COVID-19 pandemic is still with us and that we need to

continue to take every safety precaution. In line with that and as you probably know, the VA (as well as private facilities) have already begun administering vaccinations. By the time you read this there may be many of you who have received one or both shots. I urge you to take advantage of this protection.

At this point our hospital and CBOC reps still aren't able to resume their normal volunteer duties. While only some volunteer positions are being phased back in, some of our VAVS reps have joined with their respective facilities and are

participating in Buddy Check programs. I'm proud to say that even under current conditions our Post Service Officers continue to team up with County and FDVA Service Officers and continue to help our fellow veterans with claims and benefits information as well as a host of other services.

December and January brought the enactment of two pieces of legislation that will have a major impact on thousands of veterans. The National Defense Authorization Act was signed into law and after years of effort included the addition of three presumptive illnesses affecting Vietnam veterans who have and still suffer from Parkinsonism, Hypothyroidism and/or Bladder Cancer. Also, Congress passed, and the President signed into law, what is thought to be the most far-reaching veteran-oriented legislation in decades.

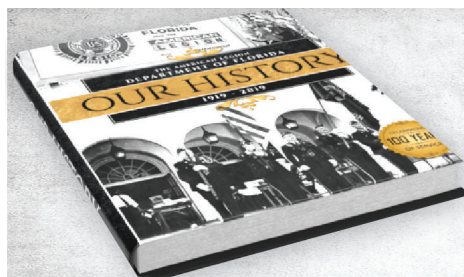
While all its provisions are too numerous to mention here, I will address only two.

First, the Deborah Sampson Act, which

directly addresses a host of major issues related to our sister veterans. Let's take advantage of this opportunity to reach out to more women veterans, offering them assistance and welcome. Another part of the legislation affects Vietnam veterans by expanding the inclusive dates, rolling back the begin-date from February 1961 to November 1955.

The Department of Florida has been the beneficiary of the generous gift of several motorized scooters. If you or a veteran you are in contact with needs one of these, please read this month's Legion Link article entitled "MOBILITY SCOOTERS AVAILABLE" for the requirements, how to submit an application, and deadline for mail and e-mail (no phone applications.)

In closing this month's article, I'm once again asking everyone to remain mindful of not only the pandemic we face but that we're all in this together so continue to reach out to all who need some help getting through it all.

Alan was a U.S. Army Vietnam War Era Veteran (1966-69) and a member of Mulberry Memorial Post 72, with 50 continuous years of membership. Alan joined the Legion shortly after being honorably discharged from service. He served in every capacity within the Post, most predominately having served as Post Commander for five consecutive years from 1986 through 1990. During his five years as Post Commander, Alan achieved five consecutive all-time highs, and post membership more than doubled.

Under his leadership Post 72 was named the Most Improved Post in the Department in 1986. He would again serve as Post Commander in 2003-05. Alan served as 7th District Commander in 1989-90. He led the 7th District to 100% membership and established an all-time high. He served as Central Area Vice Commander in 1990-91. During 1991-92, Alan served as Department Membership Chairman. Under his leadership, the Department attained the earliest 100% membership in its history and was awarded the General Henri Gouraud Trophy for being the first Category 1 (Departments over 100,000 in membership) Department in the National Organization to reach 100%. Most importantly, Alan led the Department to its 27th All-Time High. In April of 1991, Mulberry Memorial Post 172 Instituted "The Alan P. Hall Legionnaire of the Year Award" in honor of Alan's dedication and service to his Post, community, state and nation. Alan served as Department Commander in 1993-94.

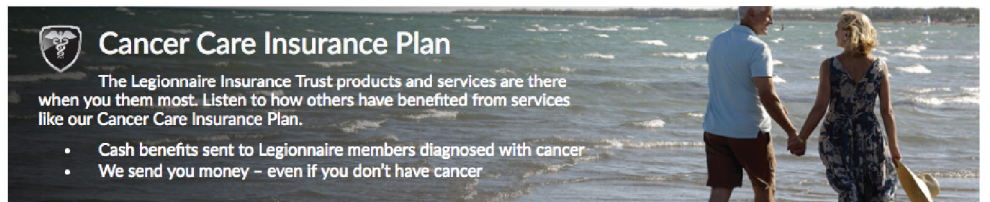
