• We are 3 weeks post installation of new officers, an unannounced visit by Jerry Brandt, Department 2<sup>nd</sup> Vice Commander and Troy Horsley, 5<sup>th</sup> District Commander, both mandated that we have until September 15, 2018 to complete an audit and identify a Financial Officer with the implication that we risk the Post closure. A couple of committee members voiced that the Post had been mismanaged likely over 2 years and to mandate a 30 day deadline is unreasonable for a proper audit, but the only recommendation provide was that we need a minimum 3 members audit committee to conduct the Post's audit.

#### **Old Business**

 Dawn Parker 3 months' assessment period as Post 233 Club Manager is in review. After a lengthy discussion between her productivity, attitude, commitment, and disingenuousness, the Executive Committee excluding the Commander voted against retaining her services as a Club Manager (10 against and 2 abstained).
