- Commander d' Avi disseminated a spreadsheet that depicts the current ongoing list of action items and their status/costs.
 - Announced the removal of two palm trees in front of the post.
 - Well status: Need to replace the submersible pump and additional equipment. The potential costs \$9,500.00. Motion approved.
 - HVAC System: Large unit suppressor has been fixed. Power surge blew the compressor out – potential \$1,400-\$1,500 for labor and refrigerant. Unfortunately, Beaches Energy recognized that we are "commercial" account and would not include the unit under warranty. The Commander did state to have a Master Electrician install one for the costs of the suppressor. Motion approved.
 - Supplied a sample of future events to include labor volunteer force from AL, SAL, and AUX. Probable future entertainment and Staff planning to ramp-up to full operations.
 - Cashflow: Commander said right now it will take about \$3500 per month without any operations for the Post to exist, and more when it opens.
