



Post installation of officers will take place on **Sunday, July 13th at 11:00am.** Legion officers are requested to wear Legion caps and your class B Freedom Polo shirts or a class A white or blue uniform shirt. Class Action Against USAA Relating To Failure To Pay Sales Tax On Covered Claims.

A class action has been filed against USAA automobile insurance companies alleging that USAA has improperly withheld sales tax from military men and women who have made auto insurance claims for their totaled vehicles. The lawsuit alleges that USAA improperly withheld up to 6% of the insured vehicle cost, which on a \$10,000 vehicle can be as high as \$600 per person.

Documents filed with the federal court show that USAA withheld sales tax from as much as 75% of policy holders who made claims for totaled vehicles in a one year period. The same documents show that the withheld sales tax at issue in the lawsuit may total over \$17 million. The lawsuit is in federal court and styled *Chantal Bastian v. United Services Automobile Association, USAA Casualty Insurance Company, Garrison Property and Casualty Insurance Company, and USAA General Indemnity Company*, No. 3:13-cv-01454, Middle District of Florida, Jacksonville Division. The federal court denied without prejudice USAA's motion to dismiss the lawsuit and the lawsuit is proceeding. **For information, you can contact attorney**

Florida Legion License Plates reminder

The State Legislature has authorized the creation of the 1st **American Legion License Plate**. Each plate costs \$35.50, with a portion of the proceeds going to support the Florida American Legion Boys State, the Gilcrest Fund and other veteran support services. We need to pre-sell 1,000 plates before production of the plate will proceed and we are almost halfway there. You can purchase a voucher for the plate through our local tax collector's office or go to the Department website to pre-order at <http://members.floridalegion.org/license-plate-preorder>

Once you purchase your voucher, you receive a specialty license plate voucher receipt. After 1,000 vouchers have been sold, production will begin and voucher holders will be notified they can exchange their voucher for their specialty plate. Order yours today!

America's Worst Charities

You've given them more than \$1 billion. They've given almost nothing to the needy.

Telemarketers with criminal backgrounds will no longer be able to call Floridians for charitable donations. Nonprofits and professional solicitors banned in one state will be banned in Florida as well. And consumers will be able to go online for more details about how a charity uses its donations under a bill Gov. Rick Scott is expected to sign into law.

The pending law gives Florida's Department of Agriculture and Consumer Services, which oversees more than 17,000 charities and 130 professional solicitors, additional manpower and stronger financial penalties for wrongdoers.

The bill would also give Florida regulators the power to revoke a charity's state sales tax exemption for certain violations. Bigger charities also will get additional scrutiny starting in July.

JUNE 14th FLAG DAY

Flag Day falls within National Flag Week, a time when Americans reflect on the foundations of the nation's freedom. The flag of the United States represents freedom and has been an enduring symbol

of the country's ideals since its early days. During both events, Americans also remember their loyalty to the nation, reaffirm their belief in liberty and justice, and observe the nation's unity.

Many people in the United States honor this day by displaying the American flag at homes and public buildings. Other popular ways of observing this holiday include: flag-raising ceremonies; Flag Day services; school quizzes and essay competitions about the American flag; musical salutes; street parades; and awards for special recognition.

Organizations such as The National Flag Day Foundation are actively involved in coordinating activities centered on the event and keeping the flag's traditions alive. Following Flag Day is Honor America Days, a 21-day period through to Independence Day (July 4) to honor America. During this period, people hold public gatherings and activities to celebrate and honor the nation.

On June 14, 1777, the Continental Congress replaced the British symbols of the Grand Union flag with a new design featuring 13 white stars in a circle on a field of blue and 13 red and white stripes – one for each state. Although it is not certain, this flag may have been made by the Philadelphia seamstress Betsy Ross, who was an official flag maker for the Pennsylvania Navy. The number of stars increased as the new states entered the Union, but the number of stripes stopped at 15 and was later returned to 13.

In June 1886 Bernard Cigrand made his first public proposal for the annual observance of the birth of the flag when he wrote an article titled "The Fourteenth of June" in the old Chicago Argus newspaper. Cigrand's effort to ensure national observance of Flag Day finally came when President Woodrow Wilson issued a proclamation calling for a nationwide observance of the event on June 14, 1916. However, Flag Day did not become official until August 1949, when President Harry Truman signed the legislation and proclaimed June 14 as Flag Day. In 1966, Congress also requested that the President issue annually a proclamation designating the week in which June 14 occurs as National Flag Week.

The President is requested to issue each year a proclamation to: call on government officials in the USA to display the flag of the United States on all government buildings on Flag Day; and to urge US residents to observe Flag Day as the anniversary of the adoption on June 14, 1777, by the Continental Congress of the Stars and Stripes as the official flag of the United States.
