

PC Warwick addressed the SAL E-Board with Post's future and dismal revenue projections through September 2025. Much discussion about banking and BINGO compliance with IRS regulations; Post in compliance. PC Warwick stated, "THAT WE WILL NOT TOUCH YOUR MONEY." PC Warwick reported the start-up of the QUEEN OF HEARTS this Friday (July 25<sup>th</sup>). Payout percentages 10% money; 30% House, and 60% to the winner. PC Warwick addressed to potential charges for Post/bartender usage of \$30 to protect the Post from liabilities; approved to get Mike Sharr certified and become a non-compensated employee to protect the Post. VC2 Correia expressed personal sacrifices with spending over \$600 (of his own money) this past week on the Post. Post Finance Officer resigned; no replacement was nominated to date.
- Finance Officer (FO) Kirkwood addressed the "balancing act" of being a SAL Officer along with Legion Judge Advocate to the Post Commander. Expressed the importance of moving forward with "positive" vision versus dwelling on the past.
